

Pro-Life Report

Lenten Volunteers Needed to Save Babies in Santa Barbara



ould you like to make this year's Lent especially pleasing to God and His Mother? Here's good news: you can join your fellow Knights, their families and other citizens in saving babies from the abortionists through the exciting "40 Days for Life" campaign.

The essence of 40 Days for Life is simple: to have at least two people praying in front of an abortion center every hour it's open, throughout the 40 days of Lent. Participants commit to praying during a certain hour on a particular day of the week throughout Lent.

So far, these prayer campaigns have saved 6,749 babies in 481 cities in 15 countries! Plus, 75 abortion workers have quit their jobs and 27 abortion centers have closed!

Santa Barbara's first 40 Days for Life effort (2011) almost certainly saved three babies down at Planned Parenthood (518 Garden Street), and we have reason to believe it saved many more.

Fr. Frank Pavone of Priests for Life says women who've had abortions often tell him that when they were going for their abortion, they were looking for a sign from God that they shouldn't do it. **So when you take part in 40 Days for Life, you might be that "sign!"** (The late, great pro-lifer John Blewett of Santa Paula was convinced that pro-lifers save babies <u>every time</u> they're in front of the abortion center.)

40 Days for Life isn't a protest, it's purely a prayer effort. Even very elderly people and moms with babies take part.

GENERAL MEETING OF COUNCIL 1684 WEDNESDAY, FEBRUARY 13, 2013

Twelve members were present when Grand Knight Steve Romofsky called the Council meeting for February to order at 6:34 p.m. Upon closing the meeting doors, Warden James Bauer verified membership cards, and the Grand Knight led the opening prayer.

The minutes of the January meeting were accepted as read.

The Grand Knight reported on the following items:

- Worthy Grand Knight Steve Romofsky reported that the Clergy Appreciation Dinner was a grand success. He thanked all those involved and gave thanks to Council 5300 for their support.
- The February 27 Valentine's Day Social will be highlighted by "Bruce Garcia's world famous Taco Bar." There will also be a 50/50 raffle. This event is no charge for Knights and their spouse.
- Please note that the Saint Patrick's social will be on Thursday, March 14 this year. The regular business meeting of the Council will fall on March 27 this month
- There will be a Centennial Committee meeting at the home for Steve Romofsky next Wednesday when the committee will continue work on the May Latin Mass, the June celebration, and other details.

Under membership, there were no new applications. However, Brothers Steve Romofsky, Mark Weitstock, Ray Charpentier, John Green, and Bruce Garcia will be taking our candidates to Moorpark for their Third Degree Exemplification on February 17.

Under communication, the Council received a gracious note from Sister Barbara Dugan thanking the Council for "the wonderful appreciation dinner and words of gratitude to the clergy and religious." The Council also received appreciation letters from St. Vincent's and Catholic Charities for our donation of \$1,000 to each from the Knights Nite Out in October.

Under the Treasurer's report, the Council's February financial statement is not included due to the resignation of Brother Bob Roux as Treasurer.

The report from the Clergy Appreciation Dinner shows a loss to the Council of \$429 after \$1,725 in ticket sales and \$2,154 in costs with most of the expenses paid. Brother Ralph Karleskint catered the event and gave the Council a hefty discount.

The financial secretary reported seven bills paid.

Under unfinished business, Brother Ray Charpentier spoke for changing the Council's name to the Father Virgil Cordero Santa Barbara Council. A motion was made and seconded. The first motion was followed by a motion to table it until the next meeting to give Council members time to think about it.

It was moved and seconded. After discussion, the motion to table the original motion until the March meeting was passed.

Under New Business, a resolution to increase the budgeted amount we give to Bishop Diego Garcia High School, Notre Dame School, and Our Lady of Mt. Carmel School by \$8,000 was read and discussed.

Whereas Council 1684's investments for 2012 have increased significantly and our major charity fund is Scholarships, therefore, we propose that an additional \$8,000 be transferred to our scholarship fund, with \$4,000 being added to BDHS, and \$2,000 to Our Lady of Mt Carmel, and \$2,000 to Notre Dame School*.

Under the Good of the Order, Brother Hank Gómez encouraged the Council's consideration and support for a charitable golf tournament benefitting Habitat for Humanity. The \$125 entrance fee covers 18 holes of golf, a cart, and dinner with the chance to win prizes.

Brother Ray Charpentier told the Council that Brother Bob Roux has resigned as Treasurer, citing health concerns. Brother Bob will be sorely missed by the rest of the officers of Council 1684 for his long years of service to the Council as its Treasurer.

Under Prayers for the Sick or Distressed, all brother Knights of Council 1684 are asked to pray for the health and comfort of Brother Bob Roux.

Following a closing prayer and the Pledge of Allegiance by Worthy Grand Knight Steve Romofsky, the Council meeting for February adjourned at 7:48 p.m.

The Council re-opened at 7:50 p.m. and the resolution was read a second time.

Deacon's Corner:

What Jesus Suffered for Each and Every One of Us Cannot be Measured

y brothers in Christ, in order to prepare ourselves to commemorate the glorious Resurrection of our Lord Jesus Christ on Easter Sunday, the Easter Celebration includes special Feasts that have been associated with the baptism of new converts, the reconciliation of penitents, the consecration of the holy oils, the washing of the feet and the commemoration of the Blessed Eucharist, and the reading of the Passion Story.

Holy Thursday is the night on which our Lord Jesus celebrated the Last Supper with His disciples. While Jesus had been preparing His disciples for some time, hinting to them that He was about to be betrayed and crucified, the disciples did not appear to perceive what Jesus was telling them.

The Feast of Holy Thursday is in remembrance of the institution of the Sacrament of the Holy Eucharist. From this Sacrament, the Bread of Life, come the inheritance of salvation and eternal life in the loving and nurturing vision of God in His Kingdom.

Our Celebration and remembrance of Good Friday; reminds us that, "He who was without sin, took upon Himself the burden of our sins and allowed Himself to be led to the slaughter like a lamb. Oppressed, afflicted, He did not open His mouth to defend Himself against His aggressors".

The mental and physical pains that the Lord Jesus suffered for each and every one of us cannot be

measured. Just the thought of wearing a crown of thorns with needles piercing the skin of our head is enough to frighten us.

But Jesus suffered more than that. His back was whipped with forty lashes. In pain and weakness, He had to carry the Holy Cross to the place of His crucifixion on a shoulder. He endured mockery, even being slapped in the face by one who did not like His answer.

Some of us cannot associate with the crucifixion, but we can associate with a slap in the face because we may have witnessed such an incident during our lives. Such an action is offensive. It stays in our mind for a long time, sometimes for life. Just the thought of Jesus having been slapped in the face is enough to raise our blood pressure. It makes us want to reach out and to slap that person right back. But that is not the Christian way.

And to add to all this suffering, Jesus had nails pierce His hands and feet to the wood.

When we leave Church each Sunday, let us not forget what Jesus endured for us. Each time we look at a crucifix, let us remember that the look on the face of Jesus was not a look of pain and suffering. It was a look of love, a love for each and every one of us.

Poll Finds More than 8 in 10 Americans Favor Significant Abortion Restrictions

Pour decades after the Supreme Court's controversial decision in Roe v. Wade legalized abortion throughout the United States, a new K of C-Marist Poll shows that more than 8 in 10 Americans (83 percent) favor significant restrictions.

The poll reveals that support for significant abortion restrictions has increased by four points since last year – rising from 79 percent to 83 percent.

Of the 83 percent who support significant restrictions on abortion, 10 percent believe abortion should never be permitted; 12 percent believe abortion should be allowed only to save the life of the mother; 34 percent would restrict abortion only to cases of rape or incest, or to save the life of the mother; and 27 percent would limit abortion to – at most – the first three months of pregnancy.

Just 11 percent would allow abortion at any time, while 6 percent would allow it during the first six months of pregnancy.

"After four decades of legalized abortion in this country, Americans have had ample time to understand that abortion has terrible consequences," said Knights of Columbus Supreme Knight Carl Anderson. "They understand abortion's true legacy – a child loses life, and parents lose a child. And after witnessing the effects of abortion for the past 40 years, Americans are not legally or morally comfortable with that legacy. It is time for our country to chart a new course on this issue – a course that protects both the mother and the child."

The survey also found that nearly 6 in 10 Americans (58 percent) believe abortion is "morally wrong." And 84 percent of Americans say laws can protect both mothers and unborn children.

"For years polls have found that Americans divide on labeling themselves as pro-life or pro-choice," said Lee Miringoff of The Marist Poll. "By asking more detailed questions about their specific views on abortion, we have been able to go beyond those labels to get a more complete picture of what Americans actually think about this issue."

The newly released survey is the latest in a series of polls commissioned by the Knights of Columbus and conducted by The Marist Institute for Public Opinion. This K of C-Marist Poll data was gathered via a telephone survey of 1,246 adults residing in the continental United States and has a margin of error of ±2.8 percentage points. Data were collected from December 4 through 6, 2012. Additional information is available at www.kofc.or
