GENERAL MEETING OF COUNCIL 1684

WEDNESDAY, JANUARY 8, 2014

Eleven members were present when Grand Knight Steve Romofsky called the January Council meeting to order at 7:38 p.m. Upon closing the meeting doors, Warden James Bauer verified membership cards, and the Grand Knight led the opening prayer and Pledge of Allegiance.

The minutes of the December meeting were approved as read.

The Worthy Grand Knight reported on the following items:

- The Worthy Grand Knight commended the Knights who helped with the preparation and the Treble Clefs' performance, but noted that we need to do a better job of getting our brother Knights out to our socials as attendance was poor.
- The Clergy Appreciation Dinner is being sponsored by Council 5300 and is to be held at the St. Rafael's Parish Hall at 6 p.m. on January 22 for a cost of \$15 per person. Tickets will be available at the January 8 Council meeting or at the door.
- The Valentine's Dinner social will be on February 5, tickets are free for Knights and their spouses. The February business meeting will be held February 26. Remember to mark your calendars.

Under the Treasurer's Report, the Council's January bank statement reflects a balance of \$8,153.17 after deposits of \$3,135.70 and withdrawals of \$2,796.61. The Christmas social showed income of \$524 and expenses of \$604.03 for a loss of \$80.03.

The Financial Secretary reported five bills paid.

Under Membership, Council 5300 will host a Second Degree Exemplification in February.

Under Communication, Council 1684 received Christmas messages and well wishes from Visiting Nurse & Hospice Care, Bishop Diego Garcia High School, and the Poor Clares. The Council also received a thank you letter from Brother Steve Riffero for the donation made to the Blue Jacket Teen-age Club.

Pro-Life Report

Lawmakers Decree Death Penalty for Sick Children

If a criminal murders or rapes someone in Belgium, he needn't worry: years ago, that country abolished the death penalty for even the most savage crimes. But on February 13 Belgium's parliament decreed the death penalty for the "crime" of being a sick child who's in pain.

Euthanasia killings of people over 18 have been legal in Belgium since 2002, but now the killing will spread to minors, and there's no minimum age. (In the euthanasia-ridden Netherlands, doctors already may kill boys and girls as young as 12.)

Supposedly, Belgian doctors may kill only children who ask for death with parental consent. But a doctor may also kill young children who ask for death if doctors say the boys or girls understand what they're requesting.

"This is the horrific logic of euthanasia," said anti-euthanasia expert Wesley J. Smith. "Once killing is accepted as an answer to human difficulty and suffering, the power of sheer logic dictates that there is no bottom."

Anti-euthanasia leader Alex Schadenberg told *LifeSiteNews* that "Euthanasia has been really out of control in Belgium for quite some time. We know from studies that about 32 percent of euthanasia deaths go without requests [from the patients]. Over half of euthanasia deaths are not reported."

The *Los Angeles Times* ran two opinion pieces that favored Belgium's child-killing law, calling its opponents "paranoid" and "death-squeamish."

Pioneering pro-life sociologist Fr. Paul Marx wrote a booklet, *The Mercy Killers*, describing the growing euthanasia movement in our country spreading its views among doctors and intellectuals. **He wrote this 40 years ago.** You can imagine how many powerful, influential people favor euthanasia today, considering how belief in the Christian doctrine of the sanctity of innocent human life has declined since then.

Over the years California lawmakers, including our own Hannah-Beth Jackson, have introduced bills that would let doctors murder sick people in California. We Knights must strongly oppose all such attempts to destroy a bedrock principle of civilization: that nothing ever justifies the deliberate killing of an innocent human being. We must pray...stay informed (e.g., via the Internet)...write and call our lawmakers...write letters to the editor...and spread the word among our family and friends.

It's later than we think. The lives we save might be our own.

GENERAL MEETING OF COUNCIL 1684

WEDNESDAY, FEBRUARY 26, 2014

Twelve members were present when Grand Knight Steve Romofsky called the Council meeting for February to order at 7:40 p.m. Upon closing the meeting doors, Acting Warden Steve Romofsky verified membership cards, and the Grand Knight led the opening prayer and Pledge of Allegiance.

The minutes of the January meeting were approved as read.

The Worthy Grand Knight reported on the following items:

- Council 1684 representatives met with Brother Brian of the Mission who has taken the place of David Wells regarding the Knight's use of Serra Hall. The meeting was cordial and several areas of mutual interest were discussed with more communication to follow.
- The Valentine's Day social was a big success. The Grand Knight thanked all those involved with setting up, cleaning up, serving and cooking. The flowers given to the ladies were an especially good touch.
- The St. Patrick's Day social will be on March 12, while the business meeting will be held on March 26. John Green's world famous Irish stew will be drawing a crowd from far and wide, so come a little early to get a seat.
- The Essay Contest Committee needs volunteers to help process and judge the essays.
- The Scholarship Committee, consisting of Brothers Mark Weitstock, Ray Charpentier, Nick Curran, and Steve Romofsky, is hard at work.
- Our Council website is almost complete, thanks to Brother Matt Najera and Brian Romofsky. The selection of a web hosting company and some final details will see our site up and running soon.
- A new Catholic high school named St. Therese Classical Academy located in Carpinteria will open August 25, 2014, with an expected enrollment of 15 students. Brothers Matt Najera, Bruce Garcia, and Hank Peterson have been instrumental in this process. In order to support this important step for Catholic education in our area, Council 1684 will be giving \$2,000 in scholarships to the school. With tuition of only \$5,000 per year, it is sure to draw attention.

Under the Treasurer's Report, The Council's February bank statement reflects a balance of \$7,145.72 after deposits of \$1,110.50 and withdrawals of \$2,117.95.

The Valentine's social showed income of \$218 and expenses of \$183.49 for a profit of \$34.51.

The Financial Secretary reported four bills paid.

Under Membership, the Council gave the second reading to the applications of Javier Briones and Matt Doyle. There will be a First Degree Exemption prior to the next business meeting on March 26.

Under Communication, the Council received an acknowledgement for the \$1,000 donation to the Boy Scouts of America.

Under Old Business,

- Brother John Green reported on the meeting held to discuss the direction of the Building and Equipment Fund investments. The Committee proposed a resolution, which was given its first reading. The Resolution reads as follows:

Whereas the Council now has investments in the Building and Equipment Fund partly in equities, withdrawal of income from the Fund must be controlled with a discipline and understanding of the stock market, if the Council is to have a steady income from the Fund going on into future years.

Therefore, we propose that a Building and Equipment Fund Management Committee of five members come together each Columbian year. Two of the members are appointed by the Grand Knight. The five members making up this Investment Management Committee would be the Following Knights: the Grand Knight, the Financial Secretary, the Treasurer, the Agent authorized to make transactions on the investment account with the broker at Morgan Stanley, and a Knight of the Council who has an understanding of investment management.

And further it is proposed that present officers and appointees fill the positions for the remainder of this Columbian year.

And further this Committee will be diligent in managing the investments and will meet at least once a year prior to the incoming Grand Knight's need to prepare a budget to determine the income that will be available for the budget.
