## FEAST OF JESUS, CHRIST THE KING

## Brown Signs Death Law, Endangering Our Lives — Now We Knights Must Repeal It

**The ball is in <u>our</u> court now.** Gov. Jerry Brown has signed ABx2-15, which lets doctors give death drugs to people ("assisted suicide"). We Knights must take action to repeal this law, or we, our loved ones or countless other Californians might be murdered by doctors someday.

That's because this law (co-sponsored by Sen. Hannah-Beth Jackson) can easily lead to a law that lets doctors directly kill their patients, with the patients' (alleged) con-

sent. (Sen. Jackson herself once sponsored a bill to allow such murders.) Eventually, lawmakers or judges will let doctors kill patients <u>against their will</u>, as they already do in England and the Netherlands.

"Assisted suicide" tramples on Catholic teaching, which says no one may ever target an innocent human life, whether by murder, by suicide or by aiding and abetting those sins.

What's more, it attacks the weakest and most vulnerable. People who are elderly, poor, disabled, depressed, confused or gullible. People with no family to defend them, and those without health insurance.

To save money, your health plan might refuse to pay for a life-extending medication and pressure you to take a suicide drug instead. This has already happened in Oregon.

Under ABx2-15, many people will feel obliged to commit suicide so they won't be a burden on their family, to save money for their heirs, to free up hospital beds. Inheritance-lusting children will pressure their parents to "terminate" themselves. Pharmacists could be forced to dispense death drugs or lose their jobs.

Rita Marker of the Patients Rights Council notes that death drugs "can be sent to a patient by Fed Ex, UPS, or regular mail," with no oversight whatsoever. "A patient can be tricked or forced into taking the drugs," she warns. "And no one would ever know."

We can wipe this evil law off the books, but ONLY if we grassroots citizens do our duty. **Petitions will be circulated soon for a ballot measure to repeal ABx2-15. When that happens, please sign the petition and get everyone you can to sign.** Then give every dollar you can to the repeal campaign, because wealthy pro-death forces will spend millions to defend ABx2-15. Visit noassisted suicideca.org to learn more about this deadly law. The life you save might be your own.

#### A NEW DARK AGE - PART II Reflection by Deacon Chris Sandner Brother Knight Council 1684

The following was presented on September 9, 2015 and is the second in a series that will explore the conditions that contributes to and explain the world that we find ourselves facing and how we, as Knights, might respond.

t our last meeting we put our finger on the A overall condition of the culture and the direction it is heading towards and we gave it a name- the New Dark Age. If you've been watching the news with this idea in mind you can probably begin to recognize examples of this condition. Hopefully, you're also beginning to recognize something very subtle that may be occurring within you. Let's also concede straight away a degree of anger that rises up in our throats at specific issues. But did you also notice that at some level we are becoming so used to these sorts of things smacking us in the face that we seem to put them aside, as an ostrich puts his head in the ground? Maybe out of exhaustion! Or, maybe it is the sheer volume of offenses that seem to be bearing down on us with such speed that we are forced to pick only a few that will get our attention. And to all the others, well, we can do little more than make a silent, private promise to do something, someday-maybe.

Examples of recent pressing issues that we might put off to the side in order to focus on larger more menacing priorities is the case of Russia pressing in on the Ukraine, or the President's inexcusable silence in the face of the recent rash of ambush killings of police officers. I'm sure we've all taken note of the court rulings against faith-based institutions who invoke their constitutional religious right not to participate in government forced mandates that support abortion or provide contraceptive drugs. We all celebrated when nearby Thomas Aquinas College won the first round in court only to have lost the next. In response the school's President gave public notice that the school will not comply with the mandate, period! The question I want to ask is: why hasn't the responsible authority for every single Catholic school in the country said the same thing?

There are so many more egregious offenses occurring around the world that we know we can't relax. As individuals, as Catholics, we now have to pick and choose those causes where we will put our money and energies. Intuitively, we can tell that the world is heading in the wrong direction. It seems that no one, no nation or organization, not even the United States who not so long ago had the moral authority as well as the strength of character to exert some influence, seems willing to confront what we all can see so plainly. In many cases it even appears that the U.S., is the cause. The United Nations seems only capable of wringing its hands, and even the Church seems to have lost her voice as bishops wrangle and debate each other in public about her own teachings. No one seems capable of addressing the major issues and bringing some sense to them. Look at the Middle East. As we sit here tonight, tens of thousands are being forced from their homes and are rushing across borders into Austria, Hungary, Italy and Germany. Authorities are now claiming that terrorists are mixing into the migrating populations and easily gaining entry into the west. Seventy-five percent are men, only 12% are women, and 13% are children. These are not families escaping together. We can see it and we know it's a problem that will only get worse and will find its way to our shores, if it hasn't already.

China is pushing on Japan for territorial dominance over islands and waters that only a few years ago were assumed free of dispute. And last week here at home, the State of California passed out of committee a bill to promote euthanasia so the State won't have to pay for the obligations of health care that it assumed to itself under the banner of free health care for all. This exact same bill as defeated only weeks ago but brought back during a holiday break when no one was watching. (*Since this address was delivered this bill has been signed into law.*)

And let's not forget or dismiss the absolute proof that the nation and world is losing its moral bearings, as well. The videos of Planed Parenthood officials callously negotiating and bragging of its medical and business skills in order to fetch the highest dollar for intact brains, hearts and livers of healthy, viable, unborn children. And what is the reaction of those who are in the best position to speak for society? They are either silent or they attack those who revealed the offenders. Whether silent or vocal these public leaders are complicit in the crimes. And the sad fact is that they will pay no price for their crimes, not at the ballot box or in the media.

Now, I don't intend to spend all my time each month

laying out the bad news In order to confirm what we already know. The question at hand is what do we do about it? How can we recognize and explain so that eventually we can find better ways to turn the tide?

We are still talking in broad terms to emphasize and to remove any doubt that the world is in desperate need of a course correction. We have listed only a few examples to support the claim. And so, we've made the case that in two major ways the culture, here at home and around the world, has turned in on itself in much the same way as it did in the first Dark Age (500 AD to about 1000 AD). A resurging tyranny and growing oppression around the world on the one hand, coupled with a secular mindset that distorts the purpose of real learning and honest exploration of man's nature on the other.

But here's the question, tonight. Are these different problems that need different solutions and strategies? Or, are they really just two sides of the same coin? If we get it wrong on this point we'll never make headway against the real enemies of mankind. We will forever just pick around at the edges of a few specific issues. For example, will building fences at borders really solve the problems that caused the forced migration in the first place? Stronger nations can push weaker ones into submission, but will the citizens of either really become any safer? If we play our cards right, maybe we will eventually defund Planned Parenthood, but, for how long? And, really, is there any expectation that holding tax dollars back will prevent abortions or stop the selling of body parts of the unborn? That's not to say that we shouldn't build fences, or use military might when it's warranted or stop our tax dollars from funding atrocities. The question is what are the real issues at hand?

"The New Dark Age" can now be defined and identified by the growing trends of tyranny and the closing of minds. And this definition identifies their common root, and makes us more capable of ripping it out so that we can begin to find our way out of the "darkness". All tyranny and institutional oppression of any kind can be known by the absence of freedom.

Consider education and learning. What is the real purpose of learning, whether in the classroom or the home? Why should we teach our children anything at all? Why not just force them to comply? The reason we teach children is to provide them with what they do not yet have so that when they become adults they can live freely.

It is the lack of freedom that defines tyranny and when tyrants control the resources of education and claim to be the final authority of learning there will be no freedom, for anyone, ever. We must once again understand and appreciate what freedom is, where it comes from, how societies and cultures ever attained it in the first place and recognize how we are losing it. And who is taking it away from us.

The Christian urge to turn the other cheek and pray for his enemy's redemption is simply not enough. And it won't work.

If a Knight is anything he is first and foremost willing to fight back, to protect, to guard those he loves and to pay a price if he must. He must realize and insist that his first Freedom, the freedom to believe and to live accordingly. His freedom to believe carries with it the right to object. Knight is willing to openly say, "No, I disagree!"

I'll leave you with this. Freedom is not a legal concept that describes certain societal rights. It is much larger than that. Freedom is the most critical thing to a man's understanding of himself and his nature as a human being and as a citizen.

Next time we will take a hard look at the nature of freedom and what it truly means. We will see that restoring freedom to the family, to our schools, and to the churches, will be our cause. Whatever the specific issue: abortion, migration, slavery of any kind, the lack of honesty in education, you can bet that freedom is the real root of the issue. We need to be able to recognize with precision and clarity those moments when freedom is threatened. And if we can do that, we'll know how to respond.

Tyranny cannot stand freedom, and if truth is not the ultimate focus of all learning then freedom will be lost. The road of freedom is the only road out of the New Dark Age. It is the only road that men can ever travel if he truly wishes to live in peace with other men. And who is against peace? You'll be surprised....

And in case you didn't notice, not once tonight did I invoke either our religion or God. This is key to the rest of our work.

#### **ONLY HAVING INSURANCE "THROUGH WORK" DOESN'T WORK**

o you know anyone whose life or career has drastically changed during these years of economic downturn? ## **Remembering Brother Knight Garvan F. Kuskey**



Dr. Garvan F. Kuskey of Santa Barbara died on September 21, 2015, at the age of 83. Garvan was born at St. Francis Hospital here in the City of Santa Barbara on August 24, 1933, attending Santa Barbara Catholic High School in the 1940's, and earning an undergraduate degree from UCSB. In his undergraduate years Garvan was president of Sigma Phi Epsilon fraternity, president of the Inter-Fraternity Council, and a member of the Blue Key Honor Society. He went on to earn a dental degree from the University of Southern California. After graduation he served in the U.S. Army; being stationed for 3 <sup>1</sup>/<sub>2</sub> years in Mannheim, Germany where he directed a dental clinic. On returning to Santa Barbara in 1963 he went into private practice seeing patients at his State Street office for 52 years until his retirement in 2014.


He was a Third Degree Knight of Columbus and a long-time member of the Serra Club. Of all his civic activities, his favorite was his more than 40 year association with the Santa Barbara Trust for Historic Preservation and the project to rebuild the Presidio. He served two terms as President of the organization. Donations in his memory to this organization would be appreciated.

He was preceded in death by his father, Frank Kuskey, his Mother, Mary Kuskey, and his sisters Pamela Kuskey and Patricia Kuskey.

A Mass of Christian Burial for Garvan was celebrated at Our Lady of Sorrows Church on Friday, September 25, at 10 AM followed by internment at Calvary Cemetery. At his funeral, his loving children spoke warmly about their father, remembering his determination and skills at solving problems whether it was family or career related. He was a man that enjoyed the challenge of learning as well as sharing his love for knowledge with family and friends alike.

He will be missed by his family and brother Knights of Council 1684.





Butch has just completed 40 years of service with the Santa Barbara County Sheriff's Department.






