## STATEMENT OF SUPREME KNIGHT CARL ANDERSON ON HIS APPOINTMENT TO THE PONTIFICAL ACADEMY FOR LIFE BY POPE FRANCIS

I am honored to have been appointed to the Pontifical Academy for Life by Pope Francis. The issue of the sanctity of life has been a priority for the Knights of Columbus, and for me personally. In this work, we have taken as our guide Pope Francis' words on the foundational nature of the right to life of the unborn in *Laudato Si* 120, and in *Evangelii Gaudium*, where he wrote: "Among the vulnerable for whom the Church wishes to care with particular love and concern are unborn children, the most defenseless and innocent among us. Nowadays efforts are made to deny them their human dignity and to do with them whatever one pleases, taking their lives and passing laws preventing anyone from standing in the way of this. Frequently, as a way of ridiculing the Church's effort to defend their lives, attempts are made to present her position as ideological, obscurantist and conservative. Yet this defense of unborn life is closely linked to the defense of each and every other human right." I look forward to working with Pope Francis and the Pontifical Academy for Life in supporting an authentic human ecology and building a culture of life based on a proper understanding of the right to life and the dignity of each person.

A motion to accept April 12<sup>th</sup> Minutes as printed in the Bulletin was moved/seconded/passed.

The Worthy Grand Knight reported on the following items:

- The dissolution of the Home Association will be a recurring item on the agenda. The Committee in charge of finding our way forward on this issue mandated by Supreme is changing course because the previous method lacked the flexibility needed to make the best use of our money.
- Brother José Naranjo was given the gratitude of the Council for his fantastic work on the April Essay Contest. It was a big success.
- The Scholarship Dinner on May 24<sup>th</sup> will feature chicken and tri-tip with beans, rice, salad and dessert. Brother Bruce García and his team never disappoint. - The annual Officer's Installation will take place on Saturday, June 24<sup>th</sup> at 9 a.m. in Serra Hall. A pancake breakfast will follow.

Following a closing prayer by the Grand Knight, the Council meeting for May adjourned at 8:54 p.m.

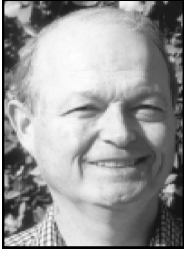

## *Pro-Life Report*

### **OREGON SENATE PASSES BILL TO STARVE PATIENTS WITH DEMENTIA OR MENTAL ILLNESS TO DEATH**

**O**n June 8, Oregon's Senate voted 17 to 13 to legalize the forcible killing of patients who have dementia or mental illness. An Oregon pro-life group said the measure, SB494, was "craftily written so as to hide its true intent."

SB494 would wipe out a patient's legal right to receive food and water as part of his or her basic treatment. Plus, it would let a patient's healthcare decision-maker force a doctor to starve the patient against the patient's will.

The bill grew out of the case of an Alzheimer's patient, Nora Harris. Her advance directive said she didn't want intravenous feeding. Though she needed help to eat with utensils, she could feed herself and wanted to eat. But her husband went to court to force her nursing home to starve her. The facility insisted on giving Mrs. Harris the option of basic food and water, and the court ruled against her husband. The family said their mother would want to be starved and dehydrated to death.

SB494 would destroy safeguards in Oregon law that guarantee conscious patients' right to ordinary food and water when they can no longer make decisions for themselves. Gayle Atteberry of Oregon Right to Life told [LifeSiteNews](#) that "It is a tragedy that the liberal senators believed the talking points of the big insurance companies and right-to-die proponents about this bill."

The bill, she warned, "opens the doors to killing conscious, non-dying adults, incapacitated because of mental illness, who have not asked to be killed. The clear motive for the killing is money. A first grader can do the math as to how much money it saves to kill a person rather than allow him to live." Only one Democrat voted against the bill and only one Republican voted for it.

Thank God, SB494 won't become law for now, but only because the bill was forwarded to an Oregon House committee that's now closed for the legislative session. Oregon pro-lifers promise an all-out fight if and when SB494 comes up again.

The bill proves that powerful forces see sick people not as precious beings made in God's own image but as costly nuisances. If someday you or a loved one becomes demented or even depressed, you too might be targeted for starvation. Don't let that happen! Have your attorney create an advance directive that insists you receive food and water. Speak up against euthanasia and assisted suicide in our state. And pray that God will protect you from the Culture of Death.

- Worthy Grand Knight discussed plans for the upcoming Fiesta operations at Mercado del Norte. He tried to get the attention of Fiesta officials regarding drink sales and give-aways by other vendors. Sign-up sheets are now available from Brother Mark. Please sign-up now.

Under Membership:

- Council gave the first reading to prospective new member Shawn Forray.

Under the Treasurer's Report:

- Council had an ending May balance of \$15,056.78 after deposits of \$35,513, withdrawals of \$25,373.07. The Scholarship dinner had income of \$465 and expenses of \$723 for a net loss for the Council of \$258.

The Financial Secretary reported three bills paid.

No new Communication was brought before the Council.

Under Old Business:

- After discussion, a motion was made to amend the slate of officers to include two inside guards in place of one. The motion to do so was seconded and passed.

Under New Business,

- Richard Rink of St. Vincent de Paul Old Mission asked for the budgeted amount for SVdP sponsored summer camp project to be increased to \$1,350 to meet the increased cost of \$450 for supporting three attendees. After discussion, it was determined that money exists in our current budget to support this worthy project funded by the Council for many years. A motion was made to fund this St. Vincent de Paul project at \$1350, seconded, and passed unanimously.
- The Friars have requested that we build our calendar for the next year and a discussion regarding that ensued. Brother Ray will work with the Friars to reserve the dates discussed.

Under the District Deputy's Report:

- District Deputy Ed Barrier sent word that he has been diagnosed with Stage -1 colorectal cancer. His prognosis is good and high hopes for a full recovery. Council 1684 asks for prayers for our Brother District Deputy.

Under Good of the Order:

- Brother Neil Chu asked that we remember our Brother Knights who may be in care facilities or home bound with prayers and perhaps the gift of a card or personal contact once in a while.
- Brother Mark Wietstock talked about engaging with children at their level to build awareness of Catholic heritage and values.
- From the entire Council for the nuptials of Brother Mark's daughter this Saturday.
- Brother Al Anglin requested that Brother Knights think good thoughts about attending this year's Mistletoe Ball that benefits the wonderful work of our local Catholic Charities organization. This year's Ball will be held at the Coral Casino on Friday, December 1.

### ONLY HAVING INSURANCE "THROUGH WORK" DOESN'T WORK

**D**o you know anyone whose life or career has drastically changed during these years of economic downturn? It's very likely that someone in your immediate or extended family or group of friends is facing financial uncertainty. Maybe there's a possibility that you (or your spouse) could lose your job or change employers.

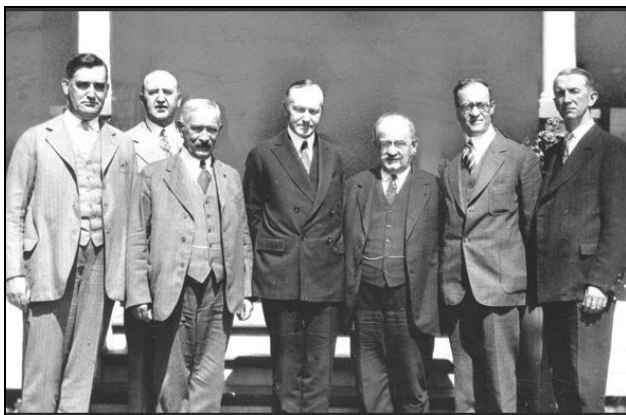
## HISTORY OF THE KNIGHT'S OF COLUMBUS IN SEARCH OF LIBERTY: 1919-1929

After the Great War, the Order continued its charitable work, offering education and employment services to returning servicemen. In less than two years, the Knights of Columbus Bureau of Employment placed some 100,000 people in jobs. The Order's presence in Europe continued as well. In August 1920, when a delegation of 235 Knights made a pilgrimage to Rome, Pope Benedict XV invited them to build several recreation centers for Roman youth. In response, the Knights constructed five playgrounds throughout the city. The architect, Count Enrico Galeazzi, went on to serve as the Knights' representative in Rome for more than six decades.

Throughout the 1920s, the Order's anti-defamation work also continued on several fronts. When the Ku Klux Klan and other "nativist" and anti-Catholic groups launched campaigns to make students attend public schools, Church leaders enlisted the Knights' support. The K of C Historical Commission, meanwhile, worked to overcome racial prejudice in American society, publishing books on the contributions of African-, Jewish-, and German-Americans

Finally, when the Mexican government began enforcing the anti-clerical provisions of its 1917 Constitution, the Knights responded with one voice. Under President Plutarco Elias Calles, who took power in 1924, priests and religious were exiled and the free exercise of religion was forbidden. In *Iniquis Afflictisque*, his 1926 encyclical on the persecution of the Church in Mexico, Pope Pius XI praised the Knights' tireless work, which included a major public education campaign, diplomatic efforts and charitable support for refugees.

- 1920: Two years after launching educational, vocational and employment programs for World War I veterans, more than 50,000 students are enrolled in K of C-sponsored evening school programs across the United States and Canada. The Order also launches a correspondence school.
- 1920: Two hundred thirty five Knights sail from New York City to France. In Paris, they are greeted by Church and civic authorities, who thank the Knights for their WWI work. In Metz, a large equestrian statue of the French patriot Lafayette, funded by the Knights, is unveiled. The K of C delegation continues to Rome, where it is received in a private audience with Pope Benedict XV on Aug. 28, 1920.
- 1923: In response to the passage of laws in Oregon prohibiting children under 16 from attending private schools, the Knights work to overturn the law. In 1925, the Supreme Court declares the Oregon law unconstitutional.
- 1924: In response to a request from Pope Benedict XV, the Knights opens St. Peter's Oratory, the first K of C recreation center for youth in Rome. Four more are established between 1924 and 1927.
- 1924: The Order's anti-defamation work resumes after World War I. The K of C Historical Commission publishes the



**K of C representatives, including Supreme Knight James A. Flaherty and future Supreme Knights Martin Carmody and Luke E. Hart, meet with President Calvin Coolidge to discuss the persecution of the Catholic Church in Mexico in 1926.**

Knights of Columbus Racial Contributions Series. Three monographs highlighting the positive contributions of African-, Jewish- and German-Americans are published.

- 1925: The Knights' Rome youth work stimulates interest in similar projects in North America, and the Columbian Squires program is established. Brother Barnabas McDonald consults with the Knights on the creation of the Squires. The institution of the first Squires circle takes place at the Supreme Council meeting in Duluth, Minn.
- 1926: Supreme Knight Flaherty, Deputy Supreme Knight Martin H. Carmody and other officers meet with President Calvin Coolidge about the persecution of the Catholic Church in Mexico. The Order launches a \$1 million educational campaign to influence American public opinion on the need for a strong stand against the Mexican government's attacks on the Church. It takes more than 10 years for the tensions to ease.
