## **SHINGLES VACCINE NOT MADE FROM ABORTED BABIES IS OK'D FOR USE BY PUBLIC**

**Have you thought about getting a shingles vaccine shot?  
Now you can do so without being involved in abortion.**

**M**ost people probably have no idea that some vaccines are produced using cells from embryonic humans. Children of God for Life (CGL), which monitors such evils, says a morally produced shingles vaccine has received FDA approval for licensing in the USA (see story on Christian Newswire, 10-25-17). Glaxo SmithKline's new Shingrix comes from yeast cells, unlike Merck's Zostavax, which uses aborted babies' cells.

"Until now, people wanting to have protection from shingles have had to either use Merck's aborted fetal version or abstain entirely," stated Debi Vinnedge of CGL. "We are absolutely thrilled that GSK has finally given the US a moral option!" Shingrix won approval in Canada, too.

Besides not being morally tainted, GSK's Shingrix is much better than Zostavax. It's 97.2 percent effective in people 50-plus. It's 90 percent effective in people 70 and older, with 95 percent immunity after four years. Merck's Zostavax works only 38 percent of the time in people 70-plus, and its immunity is a mere 40 percent after four years.

Debi Vinnedge hopes GSK will also make a moral version of the chicken pox vaccine. "There is absolutely no reason to use the remains of aborted babies to produce vaccines," she pointed out. In June, 2005, the Vatican's Pontifical Academy for Life stated:

*Doctors and fathers of families have a duty to take recourse to alternative vaccines, putting pressure on the political authorities and health systems so that other vaccines without moral problems become available. They should take recourse, if necessary, to the use of conscientious objection with regard to the use of vaccines produced by means of cell lines of aborted human fetal origin. Equally, they should oppose by all means the vaccines which do not yet have morally acceptable alternatives, creating pressure so that alternative vaccines are prepared, which are not connected with the abortion of a human fetus, and requesting rigorous legal control of the pharmaceutical industry producers.*

In April, 2015 the U.S. Conference of Bishops noted that, "The Secretariat of Pro-Life Activities agrees with the National Catholics Bioethics Center, the Catholic Medical Association, and others that manufacturers should be urged to make alternative vaccines more widely available so that Catholics and others will not face this moral dilemma."

"I commend GSK for the development of Shingrix," said John F. Brehany of the National Catholic Bioethics Center. "And I commend the thousands of people who by their prayers and petitions have helped to bring about this day. I hope they will redouble their efforts. Safe, effective, and ethical vaccines can and should be provided by the pharmaceutical companies. And everyone who respects human life and dignity should make use of these ethical alternatives."

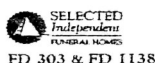

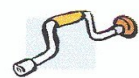

## THE WITNESS OF FRATERNAL COMMUNION

**Through our practice of charity and fraternity, we are called to bring the joy of the Gospel to others.**

IN MY COLUMN last month, I discussed some of the ideas I proposed in my keynote address to the U.S. Conference of Catholic Bishops sponsored Convocation of Catholic Leaders. I would like to follow up in this column with some additional thoughts.

In July, approximately 3,000 Catholic leaders from organizations and dioceses around the country met on the topic of “The Joy of the Gospel in America.” The convocation was inspired by the apostolic exhortation of Pope Francis titled *Evangelii Gaudium* (The Joy of the Gospel).

There were many impressive aspects of the convocation. But to me, one of the most important was the evidence that the Knights of Columbus in every diocese throughout the country is already bringing the “joy of the Gospel” to millions of our fellow Catholics and to those outside our Church through our works of charity.

In *Evangelii Gaudium*, Pope Francis calls Catholics to be “an evangelizing community” that is “filled with joy” (24), a community that is “permanently in a state of mission” (25), and a community that practices a “fraternal communion and missionary fruitfulness” (89).

We don’t often think of our local councils in precisely these terms. But if we do, we can see how our councils meet these criteria in so many different ways.

Elsewhere in *Evangelii Gaudium*, Pope Francis urges Catholics to “live in fraternity” (91) and to share “a fraternal love capable of seeing the sacred grandeur of our neighbor, of finding God in every human being” (92).

He writes: “I especially ask Christians in communities throughout the world to offer a radiant and attractive witness of fraternal communion. Let everyone admire how you care for one another, and how you encourage and accompany one another” (99).

Last month, I wrote that this is a special responsibility for every Knights of Columbus council throughout the world.

It is a special responsibility in two ways.

First, the pope’s words are a good way for us to measure how our councils are living up to our principles of charity, unity and fraternity. We should ask ourselves just how our councils offer “a radiant and attractive witness of fraternal communion” and how we care for each other as brother Knights and for our families. Many of our councils offer such a witness, but for others there may be room for improvement. In any event, every Knight should take these words of Pope Francis to heart as he approaches the work of his local council.

Second, we must make a greater effort to demonstrate within our parishes how the Knights of Columbus offers an authentic model of fraternal communion. We can offer a witness of fraternity to show how all of us as Catholics can do a better job of caring for one another and how we can encourage and accompany one another in our parishes.

It might be too much to say that Knights of Columbus are experts in building fraternal communities, but for more than 135 years, Knights have experienced a fraternal communion based upon the principles of charity, unity and fraternity.

The insights of *Evangelii Gaudium* can help us live those principles as brother Knights in a more profound and authentic way.

The convocation was a historic opportunity given to us by our bishops to respond to the pope’s call for “a new chapter of evangelization.” But its lasting importance will only be realized if enough Catholics respond to this opportunity and write a new page in the history of Catholicism.

Let each of us do our part in the days ahead.

## HISTORY OF THE KNIGHT'S OF COLUMBUS

### WAR AND PEACE: 1941 - 1950



**During World War II, parts of St. Peter's Oratory, one of the K of C playgrounds in Rome, served as the headquarters for the Vatican's food distribution program for the Roman people.**

By the time Pearl Harbor was attacked and the United States entered World War II in 1941, a K of C welfare program for servicemen had been well established by Canadian Knights, built and modeled on the Knights' World War I work. In the United States, the Order's outreach to soldiers was conducted through the National Catholic Community Service organization, which itself modeled many of its programs on the Knights' war efforts.

At the Supreme Convention in 1944, the Order established a \$1 million trust fund for the children of members who died or became disabled in World War I. Following the end of the war in 1945, the Order turned its attention to the growing threats of communism and fascism. To combat these dangers, the Knights

launched in 1946 the Crusade for the Preservation and Promotion of American Ideals, which published books and pamphlets to educate the public on "the perils of communism."

Meanwhile, the postwar years saw a membership boom for the Order in the Philippines. Jesuit Father George J. Willmann envisioned the Knights as the premiere lay society in the Philippines and set about establishing new councils and recruiting new members. He appealed to the Supreme Council in 1947 for permission to establish three new councils there and served as the country's first district deputy. By the time Supreme Knight Luke E. Hart visited Manila in 1955, the Order had expanded to include 50 Filipino councils.

- 1941: When the U.S. enters World War II, the Order's outreach to soldiers is conducted via the National Catholic Community Service organization. The NCCS models many of its programs on the Order's successful WWI efforts.
- 1944: The Order creates a \$1 million trust fund for the education of children of members who lost their lives in or as a result of World War II. This evolves into the current scholarship fund for use at Catholic colleges and universities in the United States and Canada.
- 1945: John E. Swift is elected supreme knight. Among his first initiatives is to authorize funding for full-page advertisements in 12 major U.S. newspapers and five Canadian papers highlighting the dangers of communism. The ad offers a free copy of Msgr. Fulton J. Sheen's pamphlet, "Communism, the Opium of the People."
- 1946: The Order launches its Crusade for the Preservation and Promotion of American Ideals. Educational pamphlets on communism and the dangers of secularism are published and distributed. By August 1948, there are more than 1,300 K of C discussion groups
- 1947: Several hundred radio stations broadcast K of C-sponsored programs with the titles "Safeguards of America" and "Foundations of Our American Ideals."
