## Deacon's Corner:

### FOR CHRISTIANITY

#### JANUARY AND FEBRUARY HAVE SEVERAL IMPORTANT DATES

**A**s we move from the Christmas season into ordinary time, let's not be complaisant that our current time is simply ordinary.

During this season we first celebrate two feasts: on January 26 which is the feast of Timothy and Titus, and the Presentation of our Lord on February 2 as well as many other saints who have served as God's messengers and lived lives as examples for us all to emulate.

On January 22 we celebrate a day like no other in the liturgical calendar. In the United States it is the anniversary of the Supreme Court Ruling in the case *Roe vs Wade*. This date is designated as a day of penance for the act of abortion. Although Catholics recognize abortion as an evil and murderous act, we also are to be forgiving people; we are called to love people regardless of their past, and pray for their future.

In 1908, an Episcopalian priest named Paul Wattson proposed an octave of prayer for the return of the separated churches to Rome. Wattson proposed the week from January 18 through January 25, which is the feast of the conversion of St. Paul, who we know was the

minister to the gentiles, and united people of many nations as followers of Christ. In 1965, after Vatican II, the Catholic Church collaborated with other Christian churches to organize this week of prayer which continues to this day. We are called to pray for all Christians to unite in our fundamental ideals in the understanding and followings of Christ's teachings.

This time of year also offers an opportunity to invite non-Catholics to consider becoming in full communion with our faith through the RCIA program in our local parishes (although this is available year around). If you know of any person who may show interest in becoming a follower of Christ within the Catholic Church, please don't hesitate to offer an invitation or even become a sponsor for someone who may be seeking the relationship with God that we enjoy every day.

Our Lenten season begins in mid-February, but there is a lot of work to do in the meantime. I hope we can all celebrate the love of Christ in our lives, and remember all those who have served our faith throughout the centuries.

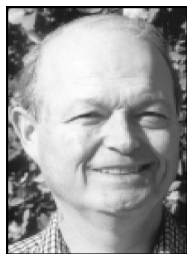

## **Lack of Babies Causing Financial Problems, Powerful Politician Warns**

**F**or years, pro-lifers have warned that dwindling birth rates worldwide are creating a nightmarish future, but nearly all U.S. politicians have been silent on the problem. Recently, though, Rep. Paul Ryan, Speaker of the House, said families should have more children.

Micaiah Bilger (LifeNews.com, Dec. 16) reported that Ryan “was discussing the problems caused by an increasingly elderly population and low birth rates. These issues have government leaders throughout the world concerned about the future of their economies, their increasingly elderly citizens and more.”


“People—this is going to be the new economic challenge for America: people,” Ryan warned. The father of three said, “I did my part, but we need to have higher birth rates in this country. Meaning, baby boomers are retiring, and we have fewer people following them in the work force.”

“We have something like a 90 percent increase in the retirement population in America,” he added, “but only a 19 percent increase in the working population in American. So what do we have to do? Be smarter, more efficient, more technology—still going to need more people. And when we have tens of millions of people right here in this country falling short of their potential - not working, not looking for a job, or not in school getting a skill to get a job - that’s a problem.”

“[U]nderpopulation has become a huge concern in many European and Asian nations,” the article noted. “Disability rights advocates and pro-lifers fear that the trend could lead to an even stronger push for euthanasia than what society already is seeing.”

The story added that Joseph Chamie, former head of the UN Population Division, “sees the problem snowballing in every region of the world except Africa, where raising families is still highly valued. Chamie calls it the ‘Historic Reversal’: whereas throughout history there have been more young people than old, now the world will witness more old people than young.

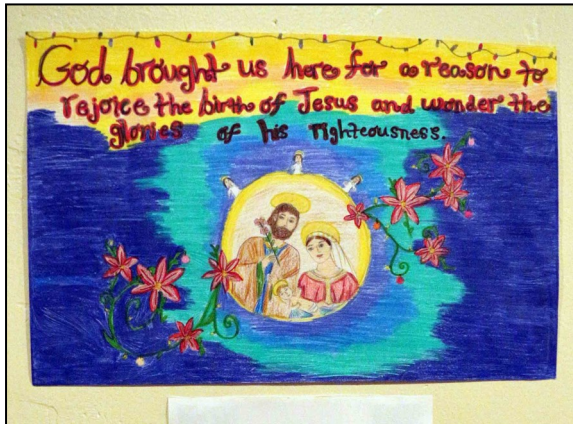

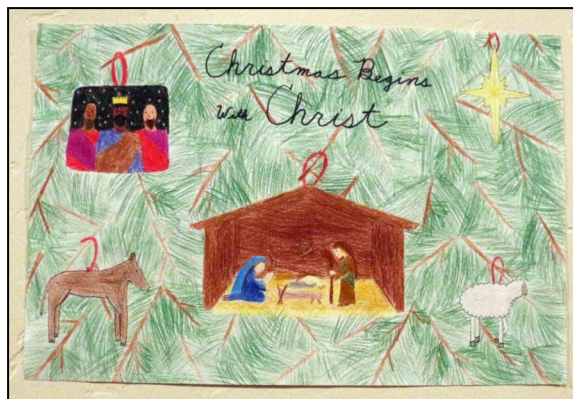

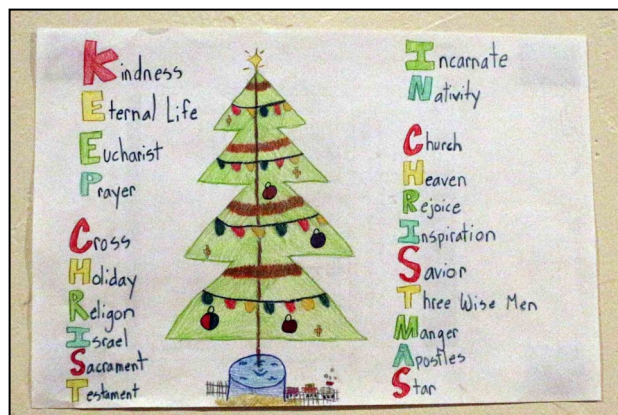

# HISTORY OF THE KNIGHT'S OF COLUMBUS

## "ONE NATION UNDER GOD": 1951 - 1960

The Knights of Columbus initiated a campaign in 1951 to lobby for the public adoption of the phrase “under God” in the U.S. Pledge of Allegiance. The Order’s Board of Directors had amended the pledge’s recitation at Fourth Degree assembly meetings and encouraged congressional representatives to adopt the same language nationwide. One year after Supreme Knight Hart took office in 1953, President Dwight D. Eisenhower signed a law that officially added the words “under God” to the pledge.

In the following years, the Knights made significant contributions to the Catholic Church in America. In 1953, a Catholic advertising program launched by Knights in Missouri was officially adopted by the Order as the Religious Information Bureau. Through the bureau, which later became known as the Catholic

Information Service when its operations moved to New Haven in 1969, the Knights printed and disseminated brochures and pamphlets about the Catholic faith. The program also included a correspondence course in which subscribers could learn about or clarify their knowledge of Church teachings.

Finally, the close of the 1950s saw the completion of the Basilica of the National Shrine of the Immaculate Conception in Washington, D.C. The Order contributed \$1 million toward the completion of the church’s bell tower, known as the Knights’ Tower, and more than 1,000 Knights formed an honor guard for the shrine’s dedication.

- 1951: The Order votes to fund the microfilming of irreplaceable documents from the Vatican Library, some dating to the pre-Christian era. The library at St. Louis University is named as the repository for the microfilm. By the 1956 opening of the Knights of Columbus Vatican Film Library at St. Louis University, 9.5 million manuscript pages have been microfilmed and made available for scholars.
- 1953: Luke E. Hart becomes supreme knight; he is the first supreme knight to move to New Haven to assume his duties, reflecting the development of the Knights as a corporation.
- 1953: The Knights of Columbus purchases for \$2.5 million the land on which Yankee Stadium is built. When news breaks of the Knights’ acquisition, councils and members send congratulatory telegrams to New Haven.\
- 1953: A Catholic advertising program launched by Missouri Knights in the 1940s is adopted nationally by the Order during Hart’s administration. The ads encourage readers to learn more about Catholic teaching by contacting the Religious Information Bureau, later the Catholic Information Service.
- 1954: On June 14, 1954, Flag Day, President Dwight D. Eisenhower signs a law that adds the words “under God” to the U.S. Pledge of Allegiance, completing an effort that Knights began three years earlier.
- 1959: On May 10, 1959, Pope John XXIII becomes the first pope to visit a K of C playground in Rome.
- 1959: On Nov. 20, 1959, the National Shrine of the Immaculate Conception in Washington, D.C., is dedicated with more than 1,000 Knights forming the honor guard. Knights contributed \$1 million, via a \$1.25 per-capita assessment over five years, for construction of the 329-foot bell tower.
