Deacon's Corner:

50 YEARS OF SERVICE

Vatican II refocused the Church on its core mission, a call to evangelize by serving the world, by diakonia. In order to sacramentalize this call to diakonia the bishops restored the Order of the **Permanent Diaconate** after a hiatus of more than 700 years. Pope Francis in a recent speech to the Roman Curia reminded the Church to live and serve with a "diaconal conscience," that is, to have hearts of service to the world. Deacons are ordained to be ministers of charity and service, and so serve as sacramental reminders of the Church's mission to bring the healing love and mercy of Christ into the world. We are called, as well, to bring their stories back

to the Church so that the Church herself may become a more perfect instrument of mercy in the world. Deacons are also meant to be a beacon -- reminding each one of us that we are all called by baptism to live out this same mission of service to our broken world.

In 2018 we mark the 50th anniversary of the restoration of the Permanent Diaconate in the United States. Since that time the diaconate has grown to more than 19,000 deacons in the U.S.

We are taught not so much to worry about those sitting in the pews as those who aren't.

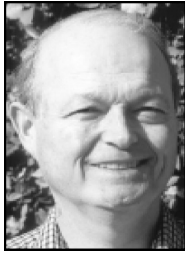

CALIFORNIA LAWMAKERS SEEK TO LEGALIZE PRESSURING PEOPLE, INCLUDING MENTALLY ILL PEOPLE, COMMIT SUICIDE

Remember in 2015 when Gov. Jerry Brown signed the bill that made it legal for doctors to give people poison to kill themselves (“assisted suicide”)? Our lawmakers promised that the bill, the “End of Life Option Act,” would bar people from pressuring others to commit suicide.

But now the pro-life Life Legal Defense Foundation (LLDF), which fights for patients’ rights, reports that **“California has gone so far as to require state-run mental hospitals to provide assisted suicide drugs to any patient who requests them—including patients who are hospitalized because of a suicide threat or attempt.”** And AB 282, a proposed new law that the Assembly has already passed, would go even farther.


LLDF says that “AB 282 (Jones-Sawyer) expressly exempts from criminal prosecution ‘aiding, advising, or encouraging’ physician-assisted suicide. The bill’s authors allege that the bill is merely a ‘technical clean-up’ to the Penal Code after the implementation of the ‘End of Life Option Act’ in 2016. In reality, AB 282 allows actions that the authors of the End of Life Option Act promised the public would not be permitted—namely, placing pressure on vulnerable patients to prematurely end their lives.”

“Medical literature,” LLDF explains, “indicates that up to 77 percent of people diagnosed with a terminal illness suffer from major depression. ... Under ABA 282, terminally ill patients—many of whom are suffering from depression, anxiety, and other mental health conditions—will be aided, advised or encouraged to request and ingest a lethal prescription. ... ”

Chillingly, “The End of Life Option Act also permits a person who stands to benefit from the patient’s death (such as a health care facility owner or beneficiary) to sign a patient’s request for aid-in-dying drugs. AB 282 would allow an ‘interested witness’ to legally aid, advise and encourage a patient to commit suicide—and sign off on the method of suicide—while gaining financially from the patient’s death.”

If AB 282 becomes law, adult children lusting for inheritances will pressure their sick, depressed parents to commit suicide. “Friends” of childless patients will pressure them, too. Moral: either never get seriously ill, or make sure AB 282 goes no farther.

Dear Brothers and Families,

The Supreme Council has conducted numerous listening sessions and surveys with both members and non-members over the last few years. Among the many findings was a strong indication that the Supreme Council should develop a new, online way to recruit potential members and form those men for committed, lifelong membership in the Knights of Columbus.

This new fraternal program seeks to help the Order maintain sustainable long-term membership growth by providing the opportunity for membership throughout the modern man's life cycle. This streamlined alternative helps acclimate men to the Order. Once a man has joined online, we will then work to incorporate him into a council and get him fully integrated with its activities.

This initiative is an important step for our Order, and presents a tremendous opportunity for membership growth and engagement. The initiative allows for:


- A Faster Way to Join – One of the most common objections to joining the Knights of Columbus is "I don't have time." Through Online Membership, a join process that can take as many as two months now takes five minutes.
- A Digital Experience – This initiative provides a new membership experience that is tailored to younger men and busier men who may not yet be ready for council-based membership. This low-pressure, low-commitment and digital experience meets men where they are, helps to form them as Catholic men, and enables us to bring more men into the fold.
- An Amplified Message – The Online Membership initiative is backed by a substantial marketing campaign that will find and work to convert prospective members.

The Online Membership Initiative:

- Does not change requirements for membership. Membership in the Knights of Columbus remains open to practical Catholic men.
- Does not eliminate degrees. Men who join online are non-degreed members. Once they are ready to convert to a local council, they are required to take the first degree.
- Does not eliminate councils. The goal of online membership is to form men for committed, lifelong and council-based membership in the Knights of Columbus. In fact, Online Membership creates a pool of recruits for local councils to engage with.
- Does not eliminate dues. Online Members are required to pay \$30 annual dues.
- Does not create a new class or type of member. Online Members are members of the Knights of Columbus. They are non-degreed members, and they do not belong to local councils, but they are not provisional or partial members.

Dear Brothers and Families,

The following information can play a significant part in your estate and tax planning.

Exclusions:

The annual exclusion for gifts is \$11,000 (2004-2005), \$12,000 (2006-2008), \$13,000 (2009-2012) and \$14,000 (2013-2017). **In 2018, the annual exclusion is \$15,000.**

The basic exclusion amount (or applicable exclusion amount in years prior to 2011) for gifts is \$1,000,000 (2010), \$5,000,000 (2011), \$5,120,000 (2012), \$5,250,000 (2013), \$5,340,000 (2014), \$5,430,000 (2015), \$5,450,000 (2016), \$5,490,000 (2017), and **\$11,180,000 (2018).**

Tax Cut and Jobs Act, Pub. L. No. 115-97:

Under this law, **the basic exclusion amount for an estate tax return for a 2018 date of death increases to \$10,000,000, before taking into account the necessary inflation adjustment.** The 2018 amount that includes the inflation adjustment has not yet been released. This information will be updated on IRS.gov as soon as it becomes available. See

This information is important to note when you are looking at options to lowering your tax liabilities. Making annual gifts up to the exclusion (\$15,000 in 2018) is a good way to reduce your taxable estate without any negative side effects.

Consider the following scenario. You and your wife want to gift monies (or property – fair market value) to your children and grandchildren in order to take advantage of the Annual Exclusion for Gifts. If your son is a member of the Knights of Columbus, he can make an application for a Single Premium Whole Life (SPWL) policy for himself, his wife and his children under the age of 18. While he is the applicant, you and/or your wife can be the owners and payors of the single premium. This single premium will generate a remarkable insurance face amount. Here are three actual examples I ran for young children of grandparents.

Grandchild #1 is a male 3 years of age. A SPWL policy would generate \$161,982 in immediate face value. The policy does not expire until the child reaches 120 years of age. The death benefit increases annually if dividends earned remain in the policy. Not only does the policy create a remarkable death benefit, it builds up cash value which may be used as collateral for student loans, mortgages, etc.

Grandchild #2 is a male of 6 years of age. Following the same scenario as for Grandchild #1, the face value would be \$145,917. And, grandchild #3 is a male of 8 years of age. With a \$15,000 SPWL the face value would be \$135,343. These are outstanding avenues of leveraging your money utilizing the Annual Gift Tax Exclusion.

HISTORY OF KNIGHT'S OF COLUMBUS - ONE CHRISTIAN FAMILY 1979 - 1999

In his 1981 apostolic exhortation *On the Role of the Christian Family in the Modern World*, Pope John Paul II wrote, "The future of humanity passes by way of the family" (*Familiaris Consortio*, 86). The pope's emphasis on the central importance of the family for the health of the Church and society reinforced the Knights' mission. Likewise, when John Paul II published an apostolic exhortation on the role of the laity in 1988 and an encyclical on the Gospel of Life in 1995, the Order urged Catholics everywhere to embrace these teachings and even published study guides to accompany the documents.

During John Paul II's pontificate, the Knights also strengthened their ties to the universal Church through increased support of the Vatican. In 1981, the Order established the Vicarius Christi Fund, annual earnings of which are presented to the pope for his personal charities. The Knights then underwrote a series of major restorations at St. Peter's Basilica in anticipation of the Jubilee Year.

In *Evangelium Vitae*, the pope called the Church "a people of life and for life," a description that the Knights sought to live up to through personal witness and efforts to build a pro-life culture. The Order also furthered the work of re-evangelization within the Church through several initiatives in Catholic education: support of Catholic schools, scholarship funds for Catholic seminaries and universities, and the establishment of a North American campus of the Pontifical John Paul II Institute for Studies on Marriage and Family

In addition to celebrating the fifth centenary of the evangelization of the New World, the Order also honored contemporary models of holiness. Supreme Knight Virgil C. Dechant presented Mother Teresa with the inaugural Gaudium et Spes Award in 1992, and the Archdiocese of Hartford officially opened the cause for Father McGivney's canonization, with the Knights' support, in 1997.

- 1979: The Order holds its first Marian Hour of Prayer program. Images of Our Lady of Guadalupe circulate among the Order's councils.
- 1979: In cooperation with the U.S. bishops, the Order underwrites the filming of Pope John Paul II's first pastoral visit to the United States.
- 1979: The Knights establishes a \$1 million Father Michael J. McGivney Fund for New Initiatives in Catholic Education to be administered by the National Catholic Educational Association. Annual proceeds are used to this day to finance programs that advance Catholic schools.
- 1981: The Order establishes the Vicarius Christi Fund, with annual earnings used for the pope's personal charities. The initial fund of \$10 million is increased to \$20 million in 1988.
- 1981: The Order begins a four-year restoration of St. Mary's Church, the birthplace of the Knights. The renovations include work on the organ, floors, pews, ceilings, statues and more. The project is capped by the placement of a 179-foot steeple atop the church.
- 1982: The Knights of Columbus celebrates its centennial. President Ronald Reagan attends the Order's 100th annual convention. Also in attendance is Cardinal Agostino Casaroli, who is sent by Pope John Paul II as the pope's personal envoy.
- 1982: The Order establishes several funds to help finance studies for priests and seminarians in Rome at pontifical colleges. These funds have been increased over the years to support seminarians and priests from the United States, Canada, Mexico and the Philippines.
- 1984: In recognition of the Order's volunteer service, President Ronald Reagan awards the Knights a President's Volunteer Action Award at White House ceremonies.
- 1985: The Order presents a mobile television production unit to the Vatican Television Center for the taping, recording and transmission of papal ceremonies. It is used during Soviet leader Mikhail Gorbachev's historic visit with Pope John Paul II that same year.
- 1985: The Order agrees to underwrite the restoration of the 65,000-square-foot facade of St. Peter's Basilica, the first time it has been cleaned in more than 350 years. Several subsequent projects have taken place at St. Peter's, including the restoration of chapels and of the Holy Year Door.
- 1988: Mother Teresa visits the Supreme Council office. The Order agrees to print copies of her Constitutions of the Missionaries of Charity, prayer cards and other religious items, a project that continues to this day.
- 1988: The Pontifical John Paul II Institute for Studies on Marriage and Family opens a North American branch in Washington, D.C., with funding from the Knights. Carl A. Anderson is the institute's first vice president and dean.
- 1989: The Bicentennial of the U.S. Hierarchy Fund is established in the amount of \$2 million to benefit The Catholic University of America. Earnings from the fund pay for projects at the university each year.
- 1992: The Knights celebrates the fifth centenary of evangelization in the Americas. Replicas of the Cross of the New World presented to Pope John Paul II on his pastoral visit to Santo Domingo in 1984 are distributed by the Knights and used in dioceses throughout the Order in prayer services highlighting the theme of evangelization.
- 1992: Mother Teresa is presented with the Order's first Gaudium et Spes Award at the 110th Supreme Convention in New York. The "Joy and Hope" award acknowledges her contributions to the Church and the world.
- 1995: The Order co-sponsors with the Diocese of Brooklyn, N.Y., Pope John Paul II's Mass at Aqueduct Racetrack during the pope's pastoral visit to the United States.
- 1997: The Archdiocese of Hartford officially opens the cause for canonization of Father Michael J. McGivney with support from the Knights of Columbus. The Father McGivney Guild is established to promote the cause.
