## Deacon's Corner:

### *What are you going to teach our Children?*

As we find yet another summer coming to an end, the tourists are dwindling in numbers, Fiesta and the local celebrations are fading memories, it is time for our faith to find added strength and welcome the young members of our Church to a new year of Religious Education.

Many of you may remember the Baltimore Catechism of old, when we memorized the responses to all the worlds' questions: Who made the world? Who is God? What is man? Etc.

Throughout the world and even in the Church today, our youth are taught much differently than a generation or two or even three ago. Our children today have access to so much information via, the internet, television and just by the sheer number of people they come in contact with every day.

The fact is that our children are learning about Christ and his mission for us, in a far different manner than we ever imagined. Volunteers are primarily teaching our youth, and they are more than likely parent or grandparent, who have experienced Christ in the World just as you and I do every day.

Today's Catechesis consists of far more than memorizing the appropriate responses to 1400 questions of the Baltimore Catechism; it helps our children and teens to live a life as a disciple

## **BLOCKBUSTER MOVIE IS SHOWING COUNTLESS PEOPLE THAT ABORTION IS BRUTAL, BASED ON LIES**

### **“Unplanned” was unexpected.**

The last thing that Planned Parenthood ever expected was millions of people watching a movie that exposed the horrors that take place daily inside the abortion giant’s “clinics.” But “Unplanned,” the story of Planned Parenthood “clinic” director Abby Johnson’s conversion to a pro-life activist, is doing just that.

More than 1,500 theaters have shown the movie in the USA alone, where it grossed \$18 million in 19 weeks. What’s more, on its first day of DVD release, “Unplanned” became Amazon’s Number One-selling DVD. Before its official release, people had already bought some 235,000 copies.

“Unplanned” tells how Abby Johnson was a rising star in a Texas Planned Parenthood center. She believed that peddling contraceptives prevented abortions, and that aborted babies couldn’t feel what was happening to them. Asked to assist with an abortion one day in 2009, she saw to her horror that the baby on the ultrasound screen looked just like her unborn baby had, and squirmed desperately to escape death.

Shaken, she quit her job, wrote the book *unPLANNED* about her change of heart, and has become one of the world’s leading pro-life activists. She’s helped 430 abortion workers to quit their jobs. Abby and her husband now have seven children and have become Catholics.

“Unplanned” has been screened in theaters in Canada, the UK and the Philippines as well. Audiences in much of Latin America are seeing it, as will moviegoers in Pakistan. It’s available at Walmart and other retailers, on Blu-ray Disc, and on demand on Amazon Prime Video.

The movie’s revelations about the abortion business have converted many pro-abortion or neutral viewers to pro-life. And only God knows how many babies’ lives it’s saving. Co-director Cary Solomon told the *Daily Signal* that a mystical experience explains its success. At first, the producers were “very worried, very scared” about making it, she said, but then “we had a Holy Spirit moment: The Spirit dropped on us and basically said, ‘Do not be afraid. This is for My glory.’”

## Officers Meeting Council 1684 Wednesday, July 10, 2019

Ten Council members were present when at 6:36 PM Grand Knight Hank Peterson called the July officer's meeting to order, the meeting beginning with a prayer. Visiting the officer's meeting was the Council's Life Insurance Field Agent George Majoue.

### Reviewing Last Month's Activities:

Grand Knight discussed the combined installation officers from Council 1684 and 5300, held on Saturday morning, June 22. ### Under New and Continuing Business:

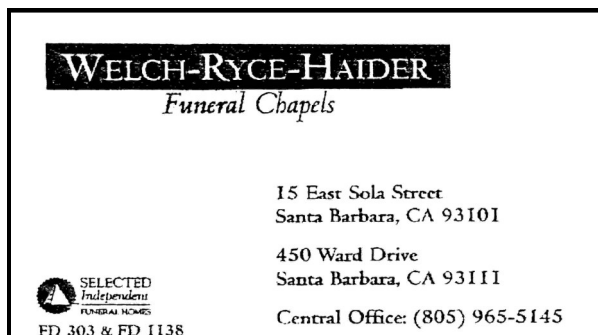

- b) Fund Raising for Intellectual Disability Drive – Council needs to provide a contribution.
- c) September Social (September 25) – need ideas for making the dinner a family event, getting families to attend (parents and children), ideas on how we can keep children occupied.
- d) Insurance Field Agent George Majoue provided a report on the rules for a council to earn the status of Star Council. Brother George provided each member attending the meeting a copy of the "Fraternal Planner for 2019-2020." The requirements for earning Star Council Award are on the back cover of the Fraternal Planner. George would like to see all eight councils in his insurance territory become Star Councils. His request is that all officers of each Council be insured members, each council have a website, and recruit new candidates for membership.
- e) Mark Wietstock reviewed documents for dissolution of the Council's Home Association. These documents will be sent to all Council members to review, and if necessary Council members can submit comments and/or questions. **Wednesday, August 14, 2019**

Call to Order:

Fourteen members, representing a quorum, were present when Grand Knight Hank Peterson called the August Council meeting to order at 7:40 p.m. The Grand Knight led the members in an opening prayer.

Minutes of the Previous General Meeting:

Minutes of General Meeting June 5, 2019 was published in the July-August monthly newsletter. Lacking a quorum, there was only an Officers Meeting Wednesday July 10.

Roll Call of Officers:

Of the 13 officers of the Council, six were absent.

Grand Knight's Report:

- Fiesta: Brother Mark Wietstock stated that all of the four-hour shifts had the proper number of volunteers. Sales of bottled Pepsi soft drinks were fair. Predicted earnings will be \$3,000.

**FIRST RESOLUTION RE DISSOLUTION**

WHEREAS "Santa Barbara Knights of Columbus Home Association" was duly organized and incorporated under California law on September 9, 1922 as California corporation No. C0100280 (hereinafter "the Home Association"), for the purpose of ownership and management of real property for the benefit and use of Knights of Columbus Santa Barbara Council No. 1684 (hereinafter "the Council");

WHEREAS the need for any independent ownership, use and/or management of real property for the benefit and use of the Council ended in or around 2009, with assumption by Santa Barbara Mission of all such activities in connection with the Council's present meeting location at Serra Hall, 2210 Garden Street, Santa Barbara, California, and with such assumption on the Mission's part continuing to the present, and

WHEREAS the Knights of Columbus Supreme Council has instructed *e.*, in that certain "Handbook for Councils Using Home Corporation Facilities" published under the direction of Supreme Knight Carl Anderson and Supreme Advocate John A. Marrella, among other things, that any local Councils operating Home Associations that no longer own or manage any real property for the benefit/use of their affiliated councils should dissolve these organizations and transfer their assets to their respective councils, to be managed/controlled directly by such councils' duly elected/appointed officers,

IT IS THEREFORE RESOLVED, by majority vote of the Home Association's membership, that the Home Association be dissolved, and that all assets thereof be transferred to the Council and thereafter managed/controlled directly by the Council's duly elected/appointed officers in accord with their regular duties, and in further accord with such other and further resolution(s) they, and the Council's membership, may deem suitable, necessary and proper.

**SECOND RESOLUTION RE DISSOLUTION OF  
SANTA BARBARA KNIGHTS OF COLUMBUS HOME ASSOCIATION**

WHEREAS the Officers and Membership of "Santa Barbara Knights of Columbus Home Association" (hereinafter "the Home Association") have resolved that the Home Association should be dissolved by appropriate processes under California law,

WHEREAS, in connection with this dissolution, all assets of the Home Association shall be transferred to Knights of Columbus Santa Barbara Council No. 1684 (hereinafter, "the Council"),

WHEREAS, in compliance with a ruling by the US Internal Revenue Service, *i.e.*, that any gains in Home Association assets causing its net asset value to exceed \$435,000 in any single year should be transferred to the Council, from approximately 1978 to the present the Council has carefully preserved, re-invested, managed, grown and thereafter used gains from all such investments to support the Council's Catholic school scholarship programs and all manner of charitable works/giving, and

WHEREAS the Officers and Membership of both the Home Association and the Council want this treatment of Home Association and Council investment resources to continue indefinitely under the future direction of the Council and its duly elected/appointed Officers, notwithstanding dissolution of the Home Association,

IT IS THEREFORE RESOLVED that:

1. Brother John Green (or such other agent(s) the Council/its Officers may hereafter designate), shall manage the new Morgan Stanley investment account to be opened to receive the assets of the Home Association in conformity with that certain Council resolution enacted in August 2014, which, among other things, requires an investment balance of 60% equities and 40% fixed income, with an allowable variance of not more than 10%, unless these particulars are amended by further resolution(s) of the Council.
2. Said account shall have no checking signatories, and no withdrawals may be made, except as needed to transfer from said account to other Council account(s) any funds/assets required to maintain the net value of the former Home Association assets/account at approximately \$435,000 as of December 31 of each calendar year.
3. Amendment of this Resolution shall require a unanimous vote of the Officers of the Council, and concurring vote of not less than 75% of the Council's regular membership.

**SECOND RESOLUTION RE DISSOLUTION**

WHEREAS the Officers and Membership of "Santa Barbara Knights of Columbus Home Association" (hereinafter "the Home Association") have resolved that the Home Association should be dissolved by appropriate processes under California law, and

WHEREAS an orderly dissolution of the Home Association will require that various legal, financial and administrative tasks be assigned and performed to effect such dissolution on behalf of the Home Association and Knights of Columbus Santa Barbara Council No. 1684 (hereinafter "the Council"),

IT IS THEREFORE RESOLVED that:

1. Attorney and Past Grand Knight/current Deputy Grand Knight Mark R. Wietstock shall prepare and submit all forms and documents required by the State of California for lawful dissolution of the Home Association, and keep the Officers of both the Home Association and the Council advised of status and expected closing date for the dissolution;
2. Treasurer John Green shall close the Home Association's books of account as/when appropriate and necessary, and file all required returns or reports thereof with the US Internal Revenue Service ("IRS") and State of California Franchise Tax Board ("FTB");
3. Treasurer John Green shall order that all securities heretofore held/managed by Morgan Stanley on behalf of the Home Association be transferred to a new account owned the Council;
4. Treasurer John Green shall close the Home Association's regular checking account at Union Bank, and deposit all funds remaining in such account into the Council's new
5. Treasurer John Green shall keep copies of the Home Association's books of account, IRS and FTB Information Returns and California Secretary of State filings from the last five (5) years, for an additional five (5) years after dissolution.

3. This account shall thereafter be administered and managed in accord with the Council's resolution(s) regarding same.

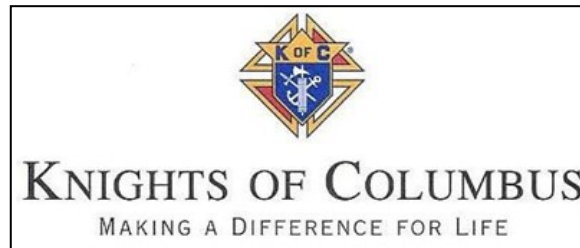

## SENATOR BEN SASSE DEFENDS KNIGHTS AT JUDICIARY COMMITTEE HEARING



The hallowed halls of the U.S. Senate were the site of a provocative but important question by Sen. Ben Sasse to a judicial nominee: “Are you now or have you ever been involved in the organization of a fish fry.”

It was funny, but it wasn’t necessarily a laughing matter.

At issue was the recent move by some of Sasse’s colleagues to question judicial nominees about their membership in the Knights of Columbus.

At a recent U.S. Senate Judiciary Committee hearing, Sen. Sasse (R., Neb.) defended the Knights of Columbus in a series of

questions to Peter Phipps, a nominee for United States Circuit Judge for the Third Circuit. Phipps is a Knight belonging to Edward Douglass White Council 2473 in Arlington, Va.

Sasse then asked Phipps if he had gotten questions for the record about being a member of the Knights of Columbus. Phipps said he had received questions during the process for his district court nomination back in May 2018.

Phipps is not the only judicial nominee to be questioned over his membership in the Knights. Last December, Brian C. Buescher was [questioned](#) about whether his Knights of Columbus membership would prevent him from “fairly and impartially” hearing cases on the U.S. District Court for the District of Nebraska. Several senators stated that the organization had “taken a number of extreme positions” on the issues of same-sex marriage and abortion.

Phipps explained to Sasse that the Knights of Columbus is a Catholic fraternal organization dedicated to uniting men of faith. He noted that it was founded in the late 19th century to help provide for families at a time where many men faced dangerous working conditions.

“It’s a charitable organization,” Phipps said. “It’s an organization that has social and recreational activities that many members of my family have really enjoyed and really benefitted from.”

Sasse then provided for the record a number of facts about the Knights:

- Knights of Columbus is the largest Catholic fraternal service organization in the world.
- In 2017 the Knights volunteered and contributed more than \$185 million to charitable organizations and activities.
- Also in 2017, Knights volunteered more than 75,600,000 service hours.
- The Knights have a proud tradition of standing against the forces of prejudice and oppression such as the Ku Klux Klan.

Sasse expressed his concern that questioning over membership in the Knights is “becoming common practice on the committee.”

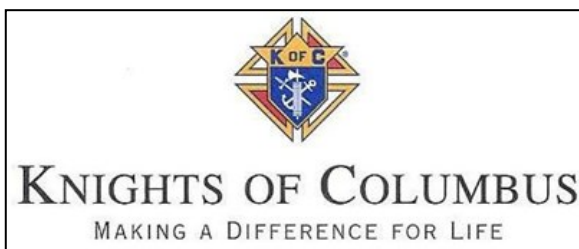
“I really hope we reconsider this new tradition on this committee of asking people about their religious commitments.”

This is not the first time Sen. Sasse has come to the aid of the Knights. In January of this year, he introduced a resolution adopted by unanimous consent that “disqualifying a nominee to federal office on the basis of membership in the Knights of Columbus” violates that anti-religious test clause of the U.S. Constitution.

Dear Brothers and Family Members:

That book, Faith and Fraternalism, notes on page 13, "...he [Fr. McGivney] was deeply interested in pursuing the topic of a Catholic fraternal insurance society among groups of Catholic laymen of New Haven." Then on page 35 Mr. Kauffman goes on, "...he [Fr. McGivney again] spent his energy in promoting the insurance feature...his emphasis on business was his pastoral concern for the social and financial security of the family."

Fr. McGivney lived both the social and the financial *insecurity* of a desperate family, with the breadwinner suddenly taken, that had to be supported. He left the seminary to work and support his mother and siblings. He didn't want other Catholic families to find themselves in such a predicament. That, and uniting men of faith, was the impetus for establishing our Order. Everyone who joined in those first years was insured; that was part and parcel of being in the organization. Now every member has a choice and every member should know what we do, and how we do it. Here's the process I use when I meet with families:

1. **Discover** – Identify & prioritize your financial goals
2. **Gather Data** – Collect facts & figures based on your current situation
3. **Analyze** – Input data, run calculations, identify shortfalls
4. **Recommend** – Propose a financial strategy designed to satisfy your goals
5. **Implement** – Choose a financial strategy and implement
6. **Periodic Review** – Review regularly, measure success, make adjustments
