# <u>Campus Ministry advocates for Catholic Tradition at</u> <u>UCSB</u>

It all started when St. Mark's parishioner Monica Morrisey took a course titled, "Catholicism" at UCSB's top-ranked Religious Studies Dept. In a conversation with (now retired) campus minister Harriet Burke about her experience, they began to ask the question, "would it be possible that the Religious Studies Dept. expand the offering of classes studying Catholicism, a major world religion, its impact in history and the contemporary world. And thus the dream began. Harriet and her husband Chuck spoke with the pastor at St. Mark's, Father Rubén Patiño, and with Bishop Curry. They began to dialogue with the folks at UCSB about the possibility of Endowing a Chair in Catholic Studies. Eight years and \$3+ million later the UC regents announced the establishment "in perpetuity" of the new Catholic Studies Chair.

One Sunday last month I asked Harriet and Monica (now Monica Bulger) to share this good news at announcement time. As it happened, the new professor, Dr. Ann Taves, was at Mass here that day. Dr. Taves comes to us from the Claremont School of Theology and the Claremont Graduate University where she was a Professor of History of Christianity and American Religion.

This effort is a prime example of what campus ministry can do to foster understanding of our Catholic Tradition and, at the same time, make a contribution to the academic life of the University. Religious studies at a state university is a unique enterprise. It is a secular, detached study of religion, which seeks to understand traditions from a variety of perspectives, while at the same time taking the faith of believers seriously.

Faculty in the Religious Studies Dept. specialize in a variety of different religious traditions. Recently endowed chairs have added experts in Sikh Studies and Tiben Bhuddism to the faculty. Efforts are underway to expand the department's offerings in Jewish Studies. This new chair in Catholic Studies will strengthen the study of Catholicism at UCSB, bring international attention to the program, draw the finest students, provide service to the community and disseminate new knowledge and insights.

The new chair is named for our beloved Fr. Virgil Cordano, OFM who has served many, many years at the Old Mission.

<u>Community Director's Report</u> Rich Scholl, Community Director

#### **MORALITY IN MEDIA**

When I took the job of Community Director, I saw that there was a need for hard information that would enable anyone to combat one of the great evils of our society: the widespread distribution and use of obscenity. In this article, you will find what you can actually do to stem this evil. To the extent that we do not take a stand and make it known, we are enablers of the evil.

There are many misconceptions, which most people have about obscenity. These misconceptions make us ineffective in the fight. The first misconception is that obscenity is too vague a concept to regulate and that it really isn't against the law or the laws don't stand up in the courts. This is incorrect. In the pivotal case of Miller v. California, the US Supreme Court defined a test for obscenity as: "1. that the average person, applying contemporary community standards, would find that the work, taken as a whole, appeals to prurient interest; 2. that the work depicts or describes, in a patently offensive way, sexual conduct specifically defined by the applicable law; and 3. that the work, taken as a whole, lacks serious literary, artistic, political, and scientific value." This definition has stood the test of time and has been incorporated into the laws of most states including the California Penal Code Sections 311-312.7. Federal law in 18 US Code Chapter 71 says that it is illegal to (among other things) mail obscene matter, broadcast obscene language, distribute obscene matter by cable or subscription television, or engage in the business of selling or transferring obscene matter.

Big media perpetrates the misconceptions (of course!). For example, Prime Time Live aired a program entitled 'Young Women, Porn and Profits: Corporate America's Secret Affair.' In this otherwise commendable program, host Diane Sawyer said that distribution of pornography is 'perfectly legal,' unaware of or ignoring the fact that

there are federal and state obscenity laws that are enforceable. NBC TV's Dateline aired a segment "On The Hunt" that looked at the invasion of unwanted ads for Internet pornography. In the otherwise commendable segment, Dateline reporter John Hockenberry said, "But this porn invasion is legal." Hockenberry also interviewed a "spam fighter" who said that if the porn spammer is based in the U.S., "all he has to do is write the phrase 'sexually oriented' on the mail and it's all perfectly legal." The Internet Corporation for Assigned Names and Numbers, a non-profit organization that oversees "domain" names for Internet addresses has added dot-xxx for the voluntary use of web sites that sell pornography. Apparently they are unaware that it is a federal crime (a felony, to be exact) to distribute 'adult' obscenity whether it is labeled or not!

Another misconception is that obscenity prosecution is a violation of the First Amendment (right to free speech) and that it is "censorship." Listen to the "Miller" court on this issue: "To equate the free and robust exchange of ideas and political debate with commercial exploitation of obscene material demeans the grand conception of the First Amendment." Furthermore the court has defined censorship as "prior restraint of speech." Prosecution of obscenity after it is promulgated is not censorship.

All of this information, and a lot more is easily obtainable through an organization called Morality in Media (MIM, website www. moralityinmedia. org). MIM is a non-profit organization that works through constitutional means to curb illegal traffic in obscenity and uphold standards of decency in media. MIM began in New York City in 1962 as a neighborhood organization after children at a grade school in Manhattan were caught circulating porn publications. Founding members included Fr. Morton Hill, Rabbi Julius Neumann and Rev. Robert Wiltenburg. They were soon joined by Rev. Constantine Volaitis of the Greek Orthodox Church. In 1973, the U.S. Supreme Court cited the report by Fr. Hill in upholding obscenity laws. MIM is fighting for a safe society with the www.obscenitycrimes.org website that enables citizens to report violations of Internet obscenity laws, with help for cities and counties to fight the spread of "sexually oriented businesses," with education efforts to dispel the false notions that obscenity is protected by the First Amendment and that obscenity is a "victimless crime." Morality in Media is committed to putting the purveyors of illegal obscenity out of business and into jail! But they need your support to carry out our mission. I urge you to explore this site. Educate yourself and report violations of obscenity law. The Justice Department supports this site and it is an invaluable resource for them.

Although it may seem that federal prosecution for obscenity isn't happening, this is not true. President Clinton dismantled the entire obscenity prosecution effort, except for "child" obscenity. No wonder a speaker at the "adult" entertainment industry national convention called him "the best friend we ever had." Enforcement under President Bush has resumed and the new Attorney General Gonzalez has organized the department to make it happen. Gonzalez had this to say at a US Attorneys' conference.

...I intend to aggressively combat the purveyors of obscene materials...You've done a good job of prosecuting child pornographers and sexual predators — and we've significantly increased obscenity prosecutions...But we can go further...I have directed Department officials to carefully review these and other federal laws to determine how we can further strengthen our hand in prosecuting obscenity. And I would like you to assess what methods you can use — or what tools you still need — to more effectively investigate and prosecute these crimes in your district...and report back to me through the Executive Office of U.S. Attorneys within 90 days."

You have some information in this article and know where to find more on the web. You know where to report violations. Don't stand on the sidelines. Your children and grandchildren are watching. Teach them too.

## <u>American Life League marks horrors of 46</u> million dead with Pro-life Memorial Day

"October 3, 2005 will be a day for all Americans to stop and reflect upon the gruesome war being waged upon innocent children in the womb," said Judie Brown, president of American Life League. "American Life League's first-ever Pro-life Memorial Day will unite people across our land under the common message that abortion is a violent act that has taken a toll of unthinkable proportions."

Nationwide participation is expected for this event, as individuals will be invited to plan and take part in Pro-life Memorial Day prayer services and similar events in their local communities on that day.

"ALL's Pro-life Memorial Day is not a political event," said Brown. "Rather, this day offers our nation a time to pause and look back, a day devoted to the memory of those 46 million children lost to surgical abortion since 1973. It is also our hope that this commemoration will unite and invigorate America's pro-life movement, renewing our determination to bring the abortion holocaust to an end."

American Life League is <u>circulating a petition</u> urging President Bush to designate the first Monday of October - the day the Supreme Court begins a new session - as Pro-life Memorial Day. The petition, as well as other information about the planned yearly event, will be available on a dedicated web site scheduled to debut in the weeks to come.

American Life League has also produced an <u>official</u> <u>T-shirt</u> for Pro-life Memorial Day, which can be viewed and purchased online.

"We feel strongly that Pro-life Memorial Day will be one of the most important days of the year for pro-life activists," said Brown. "We encourage all pro-life Americans to participate. With united actions and voices, we truly will make a difference for the babies."

#### <u>Rev. Cyril Nnadi, SMMM, Native of Nigeria Serving</u> St. Raphael for One Year Appointment

Rev. Cyril Nnadi, a member of the Congregation of the Sons of Mary Mother of Mercy, SMMM, has been appointed by his Superior General James Michael of Nigeria to serve for one year at St. Raphael's Parish.

Father Cyril was born on February 19, 1964 and attended St. Gregory Catholic Primary School in Umundugba in Nigeria beginning in 1971. He graduated from Community High School in Abba, attending the Catholic school from 1979-83. For two years, 1983-85, he attended Federal Polytechnic in Bauehi. Then he attended Alvan College of Education in Owerri.

Father then underwent the preliminary religious formations of aspirancy, postulancy and noviate respectively. He made his first religious profession in 1988. On July 17, 1997, Father Cyril was ordained to the priesthood by Lucius Ugorji, Bishop of Umuahi Diocese in Nigeria.

Father's parents, Martin and Dorathy Nnadi, are Nigerians and are secondary school teachers and proud parents of six children, four men and two women. Father Cyril is the second in the family and the only priest of his family.

"My father and mother are Knight and Lady of St. John," stated Father and "they are of great faith and love of God." He exclaimed, "Thanks to God for them. May God continue to provide for their daily bread."

Father's schooling has included:

- 1. Attending Seat of Wisdom Major Seminary of Owerri from 1988.
- 2. Earning his BA in Philosophy (B phl) at Urban University in Rome (Urbaniano) in 1993.
- 3. Earning a Bachelor of Divinity in Theology at Urban University in Rome in 1997.
- 4. Doing his post graduate studies in Special Education at National University in Lima, Peru in 1999.

Since then, Father Cyril has completed a number of assignments. His work has included parish ministry, school ministry, religious educators' ministry and formation ministry in the Minor Seminary. He served at St. Joseph Catholic Parish in Bende, Nigeria, as Vice Rector at Mercy Minor

Seminary in Bende and Dean of Studies at Loretto Boys High School in Ossah, Nigeria.

These diverse experiences have engendered in him a deep appreciation for priesthood and empathy for everyday struggle. He is optimistic that in the future lies the best. So he takes things gradually and consistently.

"My best assignment was working with the high school boys who were full of zeal to learn," remarked Father. He added, "However, Parish Ministry is equally very fruitful because it fosters good relationship in my country."

When asked to describe himself, Father stated, "I am simple and appreciative. I am open and sincere with people. I love people in their challenges. I encourage the faithful both young and old, small and great, to love Christ well."

The mercy congregation was founded in Nigeria in 1970 by Anthony Gogo Nivedo, CSSP Bishop Emeritus of Umuahi Diocese. It is a congregation of both women and men. The men go by the name, Sons of Mary Mother of Mercy, SMMM. The women go by the name, Daughters of Mary Mother of Mercy, DMMM.

The Sons carry out the following ministries or apostolate: Parish Ministry; School Ministry; School Chaplaincy; Hospital Chaplaincy; Clerical Vestments Preparation Ministry.

The priests and sisters are working in Africa, Germany, Canada, Rome and in the USA. Of the six members of his ordination class, Father noted that three are in Rome, one is in Canada, one passed away and he is the lone SMMM serving in the USA.

Father Bruce Correio, pastor, and the parish staff are thankful to Father Cyril and the SMMM congregation for all his assistance at this special time in the 109th year in the history of St. Raphael Parish.

#### GetReady for the BLITZ

Since the Knights of Columbus has implemented the Orderwide Membership Blitz, it has been successful in generating interests and gaining new members into the Order. Last October, participating councils had over 8,000 Membership Applications signed to go along with more than 10,000 completed Propsect Cards.

With the possibility of generating so much interest over such a short period of time, participation in the Membership Blitz can be useful in effectively maximizing the efforts of your council's membership team.

The Blitz, an all-out recruitment effort taken place at your parish over a set weekend, is one that is planned and organized for months. It is followed by a process of recruiting and initiating new members in the weeks following.

Dedicated preparation and follow-through after the weekend, has shown to be a proven and effective way to boost council membership....

When performed properly, the Blitz is an effective recruiting strategy, but by no means should it motivate a council to abandon their other recruiting efforts throughout the year. Other recruitment drives should continue to be a major aspect of all councils. Keep in mind that you should not have your council rely entirely on the Blitz for your recruitment. The Blitz is an effective recruiting tool; however, it is wise for it to be used as one of your plays and not your entire playbook. The manner that you promote your council during the months leading up to the Blitz will directly affect its outcome.


