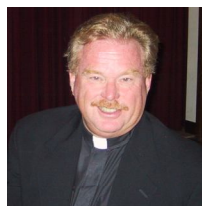

### **Chaplain's Report**

Dear Brother Knights,

At our recent meeting we voted to donate \$1,000 to support the SEARCH Retreats at St. Mark's. Fr. Joe and I thank you for your support of our ministry to UCSB students. They are the future of our Church.

SEARCH, based on the Cursillo invites young adults to a deeper (or new!) commitment to Christ. Students give witnesses relating to basic Christian topics, e.g. Living as a Christian, Faith, Prayer, the Church as Body of Christ, the Holy Spirit. There's power in this retreat to change hearts and lives.

SEARCH is also a great way for us to address the goals of our campus ministry. When students have to prepare to give a witness it causes them to go deeper and think about what they really believe and how they can communicate that faith effectively. As they prepare, they talk to friends and roommates about their Faith. As group leaders during the retreat they develop leadership skills. As support staff they learn about serving God's people out of love. Praying for the retreatants before and during the retreat they learn about the power of intercessory prayer. The students return with a new enthusiasm for their Catholic Faith.

You may have heard that the Paulists will be leaving St. Mark's in the spring. There's just not enough of us anymore. When I joined the Paulists there were 270 of us with an average age of 45. Now we're 150 with an average age of 65. This past year we've gone through a process of discerning how to carry on our Mission given this reality.

I'm sad about leaving. I've enjoyed my ministry these last 5 years, put down roots, made friends. And don't know where I will serve next year.

It's a difficult moment for St. Mark's since the future is uncertain. The Paulists are short on

priests, but so is Cardinal Mahony. There's been parish meetings to share our feelings and to look to the future. A delegation will be appointed to dialogue with Bishop Curry about the needs of the parish.

I'm confident that the work with the students will continue. Say a prayer for St. Mark's as we figure out how to carry on our Mission.

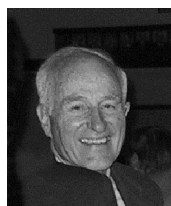

**Financial Secretary's Report**

Now that we are into the Christmas season, your Financial Secretary is prepared for a busy 6 or 8 weeks. First comes the billing then the membership cards for the Honorary Life members, then the membership card for each member as he sends in his dues.

I am optimistic about the billing for this year. It took a few years to find out why zip codes were missing on many letterheads. The address on the letterhead is used in conjunction with a window envelope. It turned out that Santa Barbara plus a nine digit zip was too many digits for the allocation in the computer. So, the computer dropped the whole zip. A little editing reduces all Santa Barbara zips to five digits except for Honorary Life members.

The "365 Club" turns out to be at least as much bookkeeping as the membership dues and cards. However, I am convinced about the outstanding benefits of the Columbian Charities, that my support would be just as strong if the work-load were tripled.

Dues are \$48 a year, based on \$12 per quarter. A discount of \$3 is given for dues received on or before Jan. 15. The discount was established as a reasonable incentive for ontime payment. Preparation of the Second Notice, the Knight Alert, and the Notice of Intent to Suspend, plus the associate postage, are the result of late payment of dues. The conversion to annual billing helped resolve some of the problem. Some quarterly payers stretched the billing process through the entire year.

The Financial Secretary stipend is authorized at 10% of the dues collected as an incentive. This FS does not use that authorization and donates his time for the betterment of the Council. Please add 10% to your dues for the "365 Club" in the same spirit of giving.

**Membership Director's Report**

Recently in the Knights Bulletin the question was asked "Does your church need an AED?" One goal of the Knights of Columbus is to help support our parish. In this case we were referring to the need for life support. An AED is an Automated External Defibrillator. In the case of cardiac arrest, these easy- to- use machines literally tell you what to do; enabling treatment to be given to a victim until paramedics arrive.

The American Heart Association estimates that the current survival rate from cardiac arrest would increase from a dismal 5% to a modest 50% simply by having an AED program in place.

My strong personal interest in providing an AED program at St. Raphael's relates to the tragic loss of my niece's husband last year. A devoted husband and father of two teen age children, he lost his life after cardiac arrest because he did not receive early treatment.

A non profit organization is now in place in the Long Beach area known as "HeartBeats For Tom." The organization is providing AED units for Parishes, High Schools and Sports Centers. The units have been approved by the Archdiocese.

I have had discussions with Father Bruce on the proposed program and have also brought the

proposal to the Parish Council. In addition, Principal Ellen Manning was very supportive of these units. There is agreement that AED units would be a tremendous life saving asset to have on the Parish grounds.

Ideally, depending on funding availability, a unit would be placed in the church, a unit in the hall and a unit at the school. A one hour training program on use of the units would be provided by the County Fire Department. I envision parishioners who have indicated an interest as well as Knights would be trained in their use.

The units cost approximately \$1200.00 each. We are now looking into alternative funding sources to make the program become a reality.

As Knights, we are entrusted with serving others. How can we not become involved in this life saving program?

### **Offering Abortion, Rebirth**

- Yes, an Arkansas doctor says, he destroys life. But he believes the thousands of women who have relied on him have been 'born again.'

FAYETTEVILLE, Ark. - Dr. William F. Harrison has forgotten how many children the woman had. He remembers she was poor and, most vividly, he remembers her response when a physician diagnosed her distended stomach as pregnancy.

"Oh ... doctor," the woman said. "I was hoping it was cancer."

This was in 1967. Harrison was a medical student and his wife was expecting their third child. It had

never occurred to him that a woman would be anything but happy to learn she was pregnant.

The next year, he trained on a maternity ward. In a 24-hour shift, it was not unusual, he said, for four or five women to come in feverish or hemorrhaging from botched abortions.

Harrison opened an obstetrics and gynecology practice, but after the Supreme Court established abortion as a constitutional right in 1973, he decided to take on an additional specialty. Now 70, Harrison estimates he's terminated at least 20,000 pregnancies.

His clinic has not been picked for years, but Harrison feels very much on the front lines these days.

Debate over President Bush's nominee for the Supreme Court, Samuel A. Alito Jr., has centered on abortion. Activists on both sides warn - or pray - that if Alito is confirmed, the court may one day reverse Roe vs. Wade.

At least a dozen states, and perhaps as many as 30, would probably continue to allow most abortions. But abortion rights activists predict that terminating a pregnancy would become a criminal act across much of the South, the Midwest and the Rocky Mountain region.

In Arkansas, for instance, the state constitution sets out "to protect the life of every unborn child from conception until birth." At least 10 other states - including Illinois, Louisiana, Pennsylvania and Utah - have similar language in their constitutions or legal codes....

He calls himself an "abortionist" and says, "I am destroying life."...

It is a few minutes before 11 a.m. when Harrison raps on the door of his operating room and walks in.

His Fayetteville Women's Clinic occupies a once-elegant home dating to the 1940s; the first-floor surgery looks like it was a parlor. Thick blue curtains block the windows and paintings of butterflies and flowers hang on the walls. The radio is tuned to an easy-listening station.

An 18-year-old with braces on her teeth is on the

operating table, her head on a plaid pillow, her feet up in stirrups, her arms strapped down at her sides. A pink blanket is draped over her stomach. She's 13 weeks pregnant, at the very end of the first trimester. She hasn't told her parents.

A nurse has already given her a local anesthetic, Valium and a drug to dilate her cervix; Harrison prepares to inject Versed, a sedative, in her intravenous line. The drug will wipe out her memory of everything that happens during the 20 minutes she's in the operating room. It's so effective that patients who return for a follow-up exam often don't recognize Harrison.

The doctor is wearing a black turtleneck, brown slacks and tennis shoes. He snaps his gum as he checks the monitors displaying the patient's pulse rate and oxygen count.

"This is not going to be nearly as hard as you anticipate," he tells her.

She smiles wanly. Keeping up a constant patter - he asks about her brothers, her future birth control plans, whether she's good at tongue twisters - Harrison pulls on sterile gloves.

"How're you doing up there?" he asks.

"Doing OK."

"Good girl."

Harrison glances at an ultrasound screen frozen with an image of the fetus taken moments before. Against the fuzzy black-and-white screen, he sees the curve of a head, the bend of an elbow, the ball of a fist.

"You may feel some cramping while we suction everything out," Harrison tells the patient.

A moment later, he says: "You're going to hear a sucking sound."

The abortion takes two minutes. The patient lies still and quiet, her eyes closed, a few tears rolling down her cheeks. The friend, who has accompanied her, stands at her side, mutely stroking her arm.

When he's done, Harrison performs another ultrasound. The screen this time is blank but for the contours of the uterus. "We've gotten everything out of there," he says.

As the nurse drops the instruments in the sink with a clatter, the teenager looks around, woozy.

"It was a lot easier than I thought it would be," she says. "I thought it would be horrible, but it wasn't. The procedure, that is."

She is not yet sure, she says, how she is doing emotionally. She feels guilty, sad and relieved, all in a jumble.

"There's things wrong with abortion," she says. "But I want to have a good life. And provide a good life for my child." To keep this baby now, she says, when she's single, broke and about to start college, "would be unfair."

**From Chapter II - I CAME THAT THEY MAY  
HAVE LIFE - Evangelium Vitae by John Paul II  
(March 25, 1995)**

44. Human life finds itself most vulnerable when it enters the world and when it leaves the realm of time to embark upon eternity. The word of God frequently repeats the call to show care and respect, above all where life is undermined by sickness and old age. Although there are no direct and explicit calls to protect human life at its very beginning, specifically life not yet born, and life nearing its end, this can easily be explained by the fact that the mere possibility of harming, attacking, or actually denying life in these circumstances is completely foreign to the religious and cultural way of thinking of the People of God.

In the Old Testament, sterility is dreaded as a curse, while numerous offspring are viewed as a blessing: "Sons are a heritage from the Lord, the fruit of the womb a reward" (Ps 127:3; cf. Ps 128:3-4). This belief is also based on Israel's awareness of being the people of the Covenant, called to increase in accordance with the promise made to Abraham "Look towards heaven, and number the stars, if you

are able to number them ... so shall your descendants be" (Gen 15:5). But more than anything else, at work here is the certainty that the life which parents transmit has its origins in God. We see this attested in the many biblical passages which respectfully and lovingly speak of conception, of the forming of life in the mother's womb, of giving birth and of the intimate connection between the initial moment of life and the action of God the Creator.

"Before I formed you in the womb I knew you, and before you were born I consecrated you" (Jer 1:5): the life of every individual, from its very beginning, is part of God's plan. Job, from the depth of his pain, stops to contemplate the work of God who miraculously formed his body in his mother's womb. Here he finds reason for trust and he expresses his belief that there is a divine plan for his life: "You have fashioned and made me; will you then turn and destroy me? Remember that you have made me of clay; and will you turn me to dust again? Did you not pour me out like milk and curdle me like cheese? You clothed me with skin and flesh, and knit me together with bones and sinews. You have granted me life and steadfast love; and your care has preserved my spirit" (Job 10:8-12). Expressions of awe and wonder at God's intervention in the life of a child in its mother's womb occur again and again in the Psalms.

How can anyone think that even a single moment of this marvelous process of the unfolding of life could be separated from the wise and loving work of the Creator, and left prey to human caprice? Certainly the mother of the seven brothers did not think so; she professes her faith in God, both the source and guarantee of life from its very conception, and the foundation of the hope of new life beyond death: "I do not know how you came into being in my womb. It was not I who gave you life and breath, nor I who set in order the elements within each of you. Therefore the Creator of the world, who shaped the beginning of man and devised the origin of all things, will in his mercy give life and breath back to you again, since you now forget yourselves for the sake of his laws" (2 Mac 7:22-23).

45. The New Testament revelation confirms the indisputable recognition of the value of life from its

very beginning. The exaltation of fruitfulness and the eager expectation of life resound in the words with which Elizabeth rejoices in her pregnancy: "The Lord has looked on me ... to take away my reproach among men" (Lk 1:25). And even more so, the value of the person from the moment of conception is celebrated in the meeting between the Virgin Mary and Elizabeth, and between the two children whom they are carrying in the womb. It is precisely the children who reveal the advent of the Messianic age: in their meeting, the redemptive power of the presence of the Son of God among men first becomes operative. As Saint Ambrose writes: "The arrival of Mary and the blessings of the Lord's presence are also speedily declared ... Elizabeth was the first to hear the voice; but John was the first to experience grace. She heard according to the order of nature; he leaped because of the mystery. She recognized the arrival of Mary; he the arrival of the Lord. The woman recognized the woman's arrival; the child, that of the child. The women speak of grace; the babies make it effective from within to the advantage of their mothers who, by a double miracle, prophesy under the inspiration of their children. The infant leaped, the mother was filled with the Spirit. The mother was not filled before the son, but after the son was filled with the Holy Spirit, he filled his mother too."

Through the extraordinary generosity of St. Raphael's parishioners for the annual Thanksgiving Food Collections held Saturday through Wednesday, November 19-23, 22 volunteer workers were able to distribute food to 64 families (283 people) in the parish community according to Fritz Cahill, the chief leader since 1982. Fritz contributes his time, energy, smile, car and other resources to deliver food and staples daily to the Catholic Charities Food Pantry in Santa Barbara. His wife, Eleanor, actually was the founder of his food collection while she and other women led the local FHA group.

Cahill, a 3rd Degree Knights of Columbus member since June 1992, beamed with pride as he noted the 'storage room' in the Church was filled to capacity with turkeys, hams, potatoes, rice, beans and all sorts of canned food items. "This is the biggest food delivery I have ever made to Catholic Charities in the past 23 years," exclaimed Cahill.

Besides the two to three large bags of mixed groceries, a turkey or ham and 5 lbs. of potatoes were given to each of the 64 local families. Fritz and his super St. Vincent de Paul volunteers gave the rest of the giant collection to Catholic Charities. It took four trucks full of food to deliver the groceries to Catholic Charities, which included 90 more turkeys and several hams. Fritz explained that the 64 families this year were able to pick out the groceries they desired by going around the tables to choose their food items.

Cahill was so thankful to his 22 parish volunteers (mostly from the St. Vincent de Paul parish group)

who helped so tirelessly during the five days. Helping Fritz were David and Martha Avila, Joe Bauer, Nilce Boyle, Seminarian Angel Castro, Rachael DeAlba, Frank Diani, Livia Doderio, Mike Donovan, Marcie and Barney Dmy, Sylvia Lindquist, Joan Magenheimer, Mary McClintock, John Meagher, Ken Mlodzik, Sharon Hurley Montross, Imelda Oden, Chawa Ramirez, Josie Schreier and Hal Thompson.

The energetic Cahill added that St. Vincent de Paul members have helped him collect and distribute food for the needy since 2001. Also, St. Raphael School children bring food and toiletry items on the First Friday of the month for Catholic Charities. Both the Spanish and English Religious Education students contribute groceries during the three special times each year.

In recent months parishioner John Meagher has been doing the daily collections for Catholic Charities since Fritz' wife Eleanor has become too ill so he needs to watch her closely. John makes one or two trips daily and Catholic Charities knows the donated food comes from St. Raphael's Parish. Cahill stated, "Apparently we (St. Raphael's) donate most of the food on a daily basis. Besides food and fresh oranges, lemons, apples, apricots and avocados, parishioners drop off clothing too. "The CC Thrift Store makes periodic trips to homes to collect furniture, washers/driers, refrigerators, etc.

"There is a very special parishioner I know that gives significant food contributions to both Catholic Charities and the Knights of Columbus," expressed Cahill. Another woman parishioner donates \$30 monthly, another buys 400 lbs. of rice each month and another 'angel' donates beans and rice monthly.

There are three major holidays when the Parish makes extra special donations for the needy: Thanksgiving, Christmas and Easter.

Currently Joe Bauer serves as President of the St. Vincent del Paul organization. Don Aubrey was the First President. Msgr. Stephen Noel Downes former pastor, was responsible for getting the group started. The group collects funds outside church after all Masses whenever there is a 5th Sunday in a month (once a quarter). With these funds, they help the needy people with their special requests: doctor

bills, car repairs, rent, utility bills and food (a \$25 certificate is provided redeemable at Santa Cruz Market).

Cahill is very thankful to the Knights of Columbus for their \$100 a month assistance, a special parishioner who gives \$75 a month, donations at the three special times each year and for Toyota of Santa Barbara for their very generous help. With these dollars Fritz purchases food in bulk (rice, beans and potatoes) for Catholic Charities.

Cahill in the past has been assisted by his wife Eleanor. His two sons, Tom and Steven, help him now. He started back in 1982 while working for the Forest Service. After retiring in 1990, Fritz made Catholic Charities his top priority and his kindness and dedication to the downtown facility has been acclaimed by politicians, Goleta Chamber of Commerce, the Santa Barbara Kiwanis, and many newspaper articles in the Santa Barbara News-Press, Goleta newspapers and the SPIRIT newspaper. The Cahills are wonderful examples of Christian charity and service to the needs of people in our parish and wider community. Fritz's concluding statement, "As in all things many people working together can do many extraordinary things for the less fortunate."

It is a great way to get out into the public and introduce the Order to your community while providing youths with a rewarding activity that yields a chance for local, state or provincial, and international recognition.

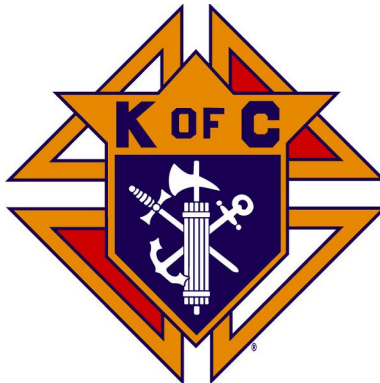
