<u>A Spiritual Thought</u>

Lent is right around the corner, February 6, and as always, Lent is a good time to pray and do penance. As <u>St. Josemaria de Balaguer</u> states in the Way: "That Christ you see is not Jesus. At best it is only the pitiful image that your blurred eyes are able to form... Purify yourself. Make your sight cleaner with humility and penance. Then the pure light of love will not fail you. And you will have perfect vision. The image you see will really be his: Jesus himself." (page 48 of the Way/Furrow/the Forge by St. Josemaria de Balaguer).

The State recently notified me that Brother Rich Scholl (our current District Warden) has resigned from active status with the Knights for personal reasons. I want to personally thank Rich for his many years of active dedicated service to the Knights. Rich has served in many officer positions in the council including the Grand Knight's position and has been an officer in our Fourth Degree Assembly as well. Brother Rich also has had time to serve lately as our Community Director and has been actively helping with both this year's Clergy Appreciation Dinner and Lenten Fish Fries. On behalf of all your Brother Knights, thank you Rich for all you have done! We hope that you can rejoin us soon.

#### **Degrees:**

There are several degrees planned in the near future:

- 1) Council 5300 will be hosting a 1<sup>st</sup> Degree on Monday, February 11, 2008. Candidates should be there at 7 PM and the Degree will start at 7:30 PM.
- 2) Council 12805 (Our Lady Mary Star of the Sea) will be hosting a 3<sup>rd</sup> Degree on Sunday, February 17, 2008. Registration will begin at 12:45 PM and the Degree will start at 2 PM. There will be a tour for the Ladies and a dinner

for all those attending immediately following the degree.

- Council 1684 will be hosting a 2<sup>nd</sup> Degree on Wednesday, February 20, 2008 at Serra Hall. Candidates should be there at 7 PM and the Degree will start at 7:30 PM.
- 4) The 3<sup>rd</sup> Degree at St. Peter Claver's in Simi Valley on March 2, 2008 has been cancelled.

#### **Programs:**

Council 1684 had a fairly quiet month of January. This February, however, the Council will be hosting their Valentine's Dinner on February 13, the 2<sup>nd</sup> degree mentioned above on February 20, and a blitz drive sometime during the month of February or March. Please try to make some or all of the events.

Council 5300 hosted their blitz drive on Saturday Sunday, 13. and January 12 and 2008. Approximately 6 or 7 potential Knights signed up to receive further information. At our council's meeting on the 14th, Brother Sam Alfano (our membership director), handed out a list of about 20 or so potential candidates to be contacted for the first Degree on February 11. Other than the blitz drive, Council 5300 also hosted their usual monthly pancake breakfast and on January 30, the annual Clergy Appreciation Dinner held in conjunction with Council 1684. In February, Council 5300 will have the 1<sup>st</sup> Degree already mentioned, and their Lenten Fish Fries on the Fridays of Lent.

Council 10067 (Saticoy) had a fairly quiet month of January themselves. They helped out with various projects around the parish (Sacred Heart). On February 16, the Council will be hosting several fundraising events: a tri-tip sale on February 3 Bowl Sunday) and a Valentine's (Super dinner/dance on February 16. There will be a blitz drive on February 3 in conjunction with the tri-tip sale. In addition to the fundraising events, the Council will be holding a 1<sup>st</sup> Degree for several of their waiting candidates. The 1<sup>st</sup> Degree's date and time are still pending.

Finally, Council 13756 (Carpinteria) was busy with projects around the church including converting one of the unused confessionals into a sanctuary for the tabernacle at St. Joseph's Church. Before, the tabernacle was less visible. Council 13756 also hosted their blitz drive on January 19 and 20. At least 5 potential candidates asked for more information and GK Ruffino Murillo stated that at least 2 of the potential candidates were very likely to become Knights. The council hopes to have a Spanish 1<sup>st</sup> Degree sometime in the next few months.

#### **Other Notes:**

- Right now, the district is at 50% of membership and 75% of insurance. We have a long way to go with membership and already 7/12 of the fraternal year is over. Brothers, we can do better! Let's get those candidates who have filled out Form 100s into a first degree. Let's step up our efforts to invite our fellow Catholics into our Order. Remember, it is every Knight's responsibility to recruit.
- The degree training that was initially scheduled for January 27 was cancelled due to the weather and the fact that our State Ceremonial Chairman, Bob Boul had another commitment. I'll work with Bob and let you know when it will be rescheduled.
- The Chapter Dinner is coming up on February 24 in Ventura at 5 PM. The Chapter dinner is always enjoyable so make your plans to attend.
- Per our State Chaplain Fr. Grace's request, we 4) started the spirituality initiative at the various council meetings in January. The initiative will take the form of a 10 minute discussion about our Supreme Chaplain Bishop Lori's article in the current issue of the Columbia magazine. The magazine and the article are available at www.kofc.org. Just click on Publications and Resources, then Columbia Magazine and you will be brought to a web page that lists the various articles in the current issue. Look for Bishop Lori's article and please read it before coming to the meeting and be ready to discuss it. We won't have time during the meeting to have it read.
- As stated last month, from December 1 to April 20, 2008, all new first degree Brother Knights will be listed in a special book that Supreme Knight Carl Anderson will present to Pope

Benedict XVI when the Pope visits the United States in April. All new first degree Brother Knights who take their first degree between December 1 and June 30, 2008 will be presented with a limited edition certificate acknowledging their joining the Knights during the 125<sup>th</sup> year of our Order. Finally, the Knight's recruiter will receive a minted medallion acknowledging their efforts.

- 6) Please be sure to visit the K of C's website (www.kofc.org) when you get a chance for up to date information about what the Order is doing at the national level. You will find a link to our Supreme Knight's new book "A Civilization of Love". Also, there is a link to a podcast of both Carl Anderson's remarks at the National March for Life as well as remarks by our Immediate Past State Deputy about the West Coast Walk for Life in San Francisco.
- 7) The State Convention is coming up in May. Make your plans now to attend. All Grand Knights and Deputy Grand Knights should be there. It is a great chance to meet fellow Brother Knights, build friendships and witness how the State works. It is also a great chance to meet some of the Supreme officers such as Emilio Moure. Last May, we had the privilege of hearing and meeting Carl Anderson!
- 8) We have been asked by the State to get behind the "California One Man, One Woman Marriage Initiative". We have been asked to collect signatures for the initiative on petition forms that can be obtained by filling out a request form at <u>www.onemanonewoman08.org</u>. #### <u>Cloning Scientist Looking at Blastocyst: ''I</u> <u>Looked Like That a Long Time Ago''</u>

LA JOLLA, California, January 18, 2008 (LifeSiteNews.com) - The news around the world is full of reports that a team of scientists at a small California private company have claimed to be the first to have created three mature cloned human embryos, using DNA taken from single adult skin cells. The report from Stemagen Corp in La Jolla, California, says one of the cloned embryos carries DNA donated by Dr. Samuel Wood, a fertility doctor who is the California-based company's founder.

Despite the research world's insistence that a cloned embryo is not genuinely a human being, Dr. Wood inadvertently admitted that scientists know this is not true. He is quoted in the Times saying, "[O]nce I saw the blastocyst and I looked at it and realized that I may well have looked something like that a long time ago, it was quite an interesting experience."

But pro-life advocates and the Vatican have denounced the work as a form of slavery that will further the ongoing devaluation of human life

Monsignor Elio Sgreccia, president of the Pontifical Academy for Life, called the work, the "worst type of exploitation of the human being". "This ranks among the most morally illicit acts, ethically speaking," he said. "As for the possible justification that this would be used to provide therapy, up to now there's been no success at this, and even if there were, it would not be permissible to use the human being as a medicine," Bishop Sgreccia added.

The clones were created by the somatic cell nuclear transfer (SCNT) technique, in which the nucleus of a human oocyte (ovum) is removed and replaced with the mature nucleus obtained from a somatic (body) cell of a donor; in this case, skin cells.

The La Jolla company gives the usual explanation that the cloned embryos can provide embryonic stem cells for use in research on Parkinson's and Alzheimer's diseases and spinal cord injuries. The embryos were allowed to develop to the blastocyst stage at which the inner cell mass forms. These cells are the embryonic stem cells so prized by researchers.

The report was published in the scientific journal, Stem Cell, and has been called by the journal "painstakingly" documented and verified. This caution comes after the 2004 scandals in which the world was shocked to discover that the Korean maverick cloning researcher Dr. Hwang Woo Suk, had faked his results in which he claimed to have created cloned human embryos and viable stem cell lines from them.

Sam Stephen Alfano, well-known St. Raphael Parishioner for his numerous positive contributions during the past 44-years, has been a major working member for the Knights of Columbus, Council 5300 since 1995.

The native of Buffalo, New York, joined the Knights on October 9, 1995 with Brother Jim Provenza his sponsor. He quickly became a  $2^{nd}$  Degree on March 11, in 1996, a  $3^{rd}$  Degree on June 23, 1996 and a  $4^{th}$  Degree on February 8, 1997.

"The best thing about being a KC member is the service to our Church, fellow Knights and our Community," specified Sam.

Sam has been a driving force as the successful Membership Committee Chairman for the past four years. "Thirty new members have been exemplified," proudly stated Sam. "This success can be attributed to cooperation of Brother Knights and the dedication of the First Degree Team," declared Sam. He added, "We are planning to have a total of 10 new members this Columbian year and retain as many members as we can."

Sam recognized his Admissions Committee Members for their key involvements. They include GK Francisco Cabrera, PGK Paul Coyne, PGK Bernie Jochum, PFN Bill McLafferty, DD Stephen Schlesselmann and PGK Ralph Wengler.

Sam's many involvements in the parish include Extraordinary Minister, Lector, Chair of the 5-Year Parish Plan, Picnic Committee Chair, Church Renovation Chair, Building Committee Chair, Parish Council Member, Founder of the St. Raphael's Golf Tournament and Co-Chair with John Barens on the Centennial Committee. Sam is also a member of St. Raphael's Conference of the St. Vincent De Paul Society, a member of the ICOP (Interfaith Community Organizing Project) and a past chairman of the Mission Council Catholic Scouting Committee. Sam is a recipient of the Archdiocese Pelician and St. George Scouting Awards.

Sam was one of five children born to Charles and Mary Giglia Alfano in Buffalo. Both parents were born in Racalmuto, Sicily. His siblings include three sisters, Connie Stanton, Mary Morganelli and Jean Mahn and a brother Tom. Born on November 28, 1930, Sam's primary grade school classes were in Buffalo. The family moved to San Gabriel, CA in July 1944. Sam attended 8<sup>th</sup> grade in Rosemead, continued in high school at El Monte and onto John Muir Jr. College in Pasadena. Sam earned his BS degree in Forestry in March, 1954 at Utah State University in Logan.

#### How Cable Television Should Be By Rich Scholl

There is a movement afoot to require the television cable industry to offer programming by the channel, called "a la carte", as an option to packages of channels. You should be able to choose and pay only for the cable channels you watch. Not a sports fan? Why should you have to pay over \$80 per year for ESPN, ESPN2 and one -- or often more -regional sports networks? Offended by Comedy Central, MTV, E! and SPIKE? Why should you have to fork over \$30 per year for programming you can't abide? But, as you know, you can't choose your cable channels. You have to buy them in expensive "packages", "bundles," or "tiers." And, the way the cable companies and programmers run the game, you often need to buy more than one tier – more than just "expanded basic" – to get what you really want. That explains why the average U.S. cable bill now tops \$50! Just how do they get away with this?

Let's start with the consolidated ownership of cable networks: 6 mega-media companies own the 20 networks with the highest programming fees. Put differently, 6 companies pretty much rule Expanded Basic. Now, add cross-ownership to the mix of For example, Time-Warner, the consolidation. second biggest cable company, owns 8 cable networks, 5 of which are typically included in the Expanded Basic tier. Comcast, the biggest cable company, owns all or a majority stake in 7 smaller cable networks (with 1 typically in the Expanded Basic tier). Now, add the fact that 5 of the biggest cable network owners are also big time owners of local broadcast television stations (and are affiliated with hundreds and hundreds more broadcast stations). In all of this, the biggest con being run on consumers is what economists call bundling. This is when one product or service cannot be bought without another. For example, NBC/Universal, the owner of CNBC, MSNBC, USA, SciFi, Bravo, and other networks, makes it very attractive for cable companies to take them all, and very hard for cable companies to pick and choose only the nets they Cable companies must secure permission want. from local broadcast affiliates to carry the affiliate over the cable system. Permission is tied to carrying not only the owner network's marquee cable networks, but also all the minor networks, such as those containing sleaze. Cleaning up the bundling scam may be a case where courts can do what elected representatives and bureaucrats cannot. A recent anti-trust, class action suit filed against the big cable companies and mega-programmers may go a long, long way in helping. It's time to bust the trust that has cost us all billions.

A recent FCC "Further Report On the Packaging and Sale of Video Programming Services To the Public", concludes that a la carte could be in consumers' best interests. Moreover, it explores several alternatives for increasing consumer choice in purchasing multichannel video programming that could provide substantial consumer benefits.

Help to end the cable programming racket. Tell your friends and family so that there is a greater national awareness of this issue. Contact your cable company, the mega-programmers, your elected representatives, the FCC, the FTC and the courts, and tell them How Cable Should Be. Cable subjected to the marketplace of consumer choice will be different than cable today. It will be far better!

<u>Knights of Columbus Protocol</u> By Grand Knight Francisco Cabrera

#### <u>Protocol Part II</u>

Continuing with more training material for all the members, here is the part II Protocol published by Brother Don Aubrey in the September, 2004 Knightline:

A second courtesy is that of standing when members of the Clergy enter or leave the Chambers. When, for example, the chaplain enters the Chambers, the Inside Guard must salute the GK and announce in a load voice, "Worthy Grand Knight". When recognized by the GK, the Inside Guard will announce: "The Chaplain of this Council has entered the Chambers." At this time, the GK will rap the gravel three times (directing the membership to rise) and announce: "Worthy Warden". The Warden will go to the center of the Chamber and salute the GK. The GK will announce, "Worthy Warden, please escort the Chaplain to his seat at the head table." The Warden will then salute the GK and DGK, proceed to where the Chaplain waits and escort him to the center of the chambers. There, both the Warden and the Chaplain will salute the GK and DGK and the Warden will escort the Chaplain to his seat by the most direct route. When the Chaplain has taken his position, the GK will rap the gavel once to seat the assembly. Note that the Chaplain does not come in and proceed to a seat by himself as does most any other member.

Similarly, when a visiting dignitary, such as the District Deputy or State Officer or similar VIP, visits the Council, his arrival will be announced in a similar manner and he will be escorted to his place in a similar manner. If, when the GK calls a meeting to order one of these VIP is present, they should take a seat in the Chamber and the GK will then direct that he be escorted to his proper place (as above). If the Chaplain or VIP departs before the meeting is adjourned he will be escorted to the door by the Warden, at the direction of the GK.
