Recently I refereed a soccer game where in my effort to show that as the Center Referee, I was knowledgeable and skilled in what I was doing, I made a call that was absolutely wrong. The call was not based on team bias, but rather a moment of forgetfulness and being afraid to ask for help on making the correct call. The call was a goal that I allowed, which tied a game where a winner must be determined. Even though the eventual result did reflect who should have won, I still had that horrible feeling of "what if the other team won?" How would they have felt and why did I make the call I did?

Each of us makes similar kinds of decisions in our daily life; right of way at stop signs, choices in the grocery store, and especially even in political discussions. Through our accumulated knowledge and skills, we often assume we know what is best, and make decisions based on those, and then when challenged on a decision, often we are so sure that we believe that we know what is best, until we realize that we have made a mistake. Where are we going wrong and how do we get ourselves into these predicaments?

As children of God, we all desire to emulate our Creator, but being human; we are destined to fall far short of that. Amongst many of our shortcomings, we lack knowledge and true purpose, as well as being driven by our own human characteristics of fear and arrogance. My error could have been easily rectified by asking for help from an assistant referee. It would have only taken a minute to do so, but I did not. That evening, after being so thankful for the rightful outcome to the game, I went home and took some corrective action on myself. I re-read the rule book so that I don't make another mistake like that again. That was the easy part, gaining more knowledge.

The hard part will be overcoming other human flaws, such as fear and arrogance. This is where we need to ask for help. How important is this decision that I am making, how will it affect others, how am I basing my decision, and even more so, do I have any apprehension (fear) of the decision I am about to make. It only takes a moment of prayer to ask for guidance. The answer we get may not be exactly what we wanted, but will point us in the right direction of the best decision. So many of life's "little" things can be handled best with the help of our Lord if only we will ask in a "little" prayer.

Other prayers are needed for those who are in our lives now and in our past, who are currently in need. Among those are Msgr. Henry Van Son who is ill. He is a former Pastor of St Raphael Church as well as Our Lady of Mt. Carmel. As a Knight of the 4<sup>th</sup> Degree, he is 84 years of age and currently resides in Beaverton Oregon. # <u>Do We Still Need Embryonic Stem Cells?</u> <u>by</u> <u>Erin Richards</u>

Since their discovery, stem cells have been hailed as the ultimate answer for crippling and incurable diseases such as Alzheimer's, Parkinson's and other conditions that leave vital organs like heart or nerves damaged beyond repair.

Researchers from the University of Cambridge, under the leadership of Professor Austin Smith, Director of the Wellcome Trust Centre for Stem Cell Research at the University of Cambridge, recently published a paper detailing a new technology that can transform adult stem cells into induced pluripotent stem cells (iPS). This technique is able to reliably reprogram adult cells into iPS rapidly and can forego the need to rely on mammalian embryos to generate pluripotent stem cells.

Working with stem cells has proved a much greater challenge than foreseen, however, as both scientific and ethical challenges confront stem cell research from all sides. Stem cells are tricky to work with and although they are indefinite, can stop dividing at any time. The best stem cells are also the cells with the least amount of differentiation (or development). These cells occur during embryonic development and the harvesting of such cells results in the death of the rest of the embryo. The resulting loss of the embryo is the cause of the ethical dilemmas concerning the usage of stem cells and the development of stem cell research.

Embryonic stem cells have a great deal of potential but the restrictions put in place for federally funded research projects have limited their use and the controversy over the ethical issues has consumed a great deal of time in the science community. This ethical dilemma can be bypassed altogether if adult mammalian cells are reprogrammed to form iPS, which are cells almost identical to those from embryonic stem cells but which come from adult tissue instead of embryos, and the same results can be obtained.

The technique for reprogramming relies on the usage of a combination of chemical inhibitors provided by Stem Cell Sciences, a company providing commercial use of stem cells and stem cell technologies. These chemical inhibitors, including use of enzymes MEK and GSK3 in combination with a cell growth promoter and leukemia inhibitory factor (LIF) provide the key to transition fully differentiated adult cells into cells that are indistinguishable from authentic embryonic stem (ES) cells.

Stem Cell Sciences developed this Culticell iSTEM<sup>TM</sup> media range to overcome the limitations in current approaches to producing reprogrammed pluripotent stem cells. Smith and his team developed this key step in the successful complete transfer of adult cells into iPS using this specific combination of enzymes, inhibitors and cellular growth indicators.

"This proprietary technique greatly facilitates the simple, most reliable and efficient route to obtaining authentic induced pluripotent stem cells and will form the basis for the industrialization of iPS cell production," noted Dr. Tim Allsopp, Chief Scientific Officer of Stem Cell Sciences. "This is an important validation of the technology Professor Smith and his team have developed and Stem Cell Sciences is very pleased to be working with Cambridge University and Professor Smith's team on this important breakthrough."

This breakthrough of complete transformation follows on the heels of previous studies in which progression to iPS was limited and extremely inefficient. This process has greatly improved both the success and efficiency rate making a reliable source to generate iPS without depending on embryonic cells.

Stem cells are unique because they have the potential to be any number of various cell types. They are undifferentiated cells, and if at the earliest stage of development, they have the ability to create a completely new individual. As such, they can be directed to make any number of useful tissues, including nervous tissue, heart tissue or a new liver.

Research with stem cells can help us develop procedures like gene therapy, testing drugs with lessened need for animal and human test subjects, genetic disorder correction and replacement of damaged tissues or organs. The possibilities are endless, applications in real world situations limitless and now the technology to propel us into the future of stem cell applications is very real.

"Encouragement from fellow Delco employees Hugo Bunke, Stan Nowak, Don Aubrey, Tom Quinn and others was the main reason I decided to become a KC member," stated Ken. One of his current goals is to contribute to the promotion of getting more active new members. Ken acclaimed, "The current members are doing a GREAT job in obtaining good YOUNG members, which I think is outstanding and unattainable by many Fraternal Organizations." other recommendation why other men join the KC's is stated thus, "To obtain the feeling of supporting worthy causes and promoting Brotherly Love." As Grand Knight, Council 5300 received a record number of awards at the Convention in '92.

Carol Grace Fessler (born December 23, 1936) also hailed from Sheboygan and her parents were proud of their four daughters and three sons.

Ken and Carol were married on April 30, 1960 at Holy Name Church in Sheboygan by Rev. Andre. Today they are the proud parents of daughters Karin 47 (Mesa Oaks), Laura 46 (Goleta), Michele 44 (Vandenberg Village), Lisa 41 (Westlake Village) and Kelly 38 (Cebada Canyon) and nine grandchildren: Davia 20, Brianna 19, Brittany 19, Ashlee 18, Grace 15, Tiffany 13, Kenny 12, Hanna 10 and Ella 6.

An interesting personal background of how they met. They were on a double date, Carol with Jim and Ken with another girl. Ken made it clear thusly, "I actually won over my bride by arriving at the most popular watering hold in Sheboygan (a bar and entertainment dwelling owned and operated by my brother), shortly before closing time. All the other guys would buy her drinks all night, but my approach was different. I'd offer to stop for hamburgers after the bar closed, and she would go with me. It probably wasn't the most economical, but the reward (Marriage that is) was well worth it."

As a youngster Ken attended Mapledale Grade School, Sheboygan Central High School and Lawrence College (now Lawrence University) in Appleton, WI. Over the last 10 years they have been very active with the SB Elks Caravaneers, serving as an officer for five years, culminating this year as the Wagon Master.

Carol worked at Joslyn Electronics, originally as a welder and advanced to buyer and finally Administrative Assistant. 
