### What FOCA Really Does BY Karen M. Berkon

The Freedom of Choice Act (FOCA) is an oppressive law mandating participation and cooperation from every American citizen in unlimited abortion. Currently, FOCA is out of committee but still awaits passage through Congress, and with the sweeping Democratic victories in the House and Senate in this past election, that could happen very soon. President-elect Barack Obama declared to a Planned Parenthood gathering on July 17, 2007, that the first thing he would do as president of the United States would be to sign the Freedom of Choice Act.

Just how will FOCA affect abortion rights and the pro-life movement in this country? FOCA's "Statement of Policy" reads:

"It is the policy of the United States that every

woman has the fundamental right to choose to bear a child, to terminate a pregnancy prior to fetal viability, or to terminate a pregnancy after fetal viability when necessary to protect the life or health of the woman."

Keep in mind the phrase "fundamental right," for it is the key to understanding the intent of FOCA. Historically, the right to abortion became law in 1973 with the Roe v. Wade Supreme Court decision that established a woman's right to abortion based on the 14th Amendment of the U.S. Constitution, and subsequently, restricted state laws on abortion. The 1992 Planned Parenthood v. Casey decision loosened those restrictions, giving states greater autonomy with regard to abortion regulation.

Since then, laws have been passed to exempt taxpayers from funding abortions both nationally, in 1976 via the Hyde Amendment, and internationally, in 2001 when President Bush restored the Mexico City Policy.

Currently, many states have parental-notification laws for minors seeking an abortion, conscience clauses exempting health-care workers and providers from participating in abortions, informed-consent laws which require consequential information for women seeking abortions, as well as various state restrictions on late-term abortions. The Partial-Birth Abortion Ban, which requires the partial extraction of a fetus from the birth canal before the abortionist performs the abortion, was upheld by the Supreme Court on April 18, 2007.

In response, the following day, Sens. Barack Obama and Hillary Clinton and others reintroduced the Freedom of Choice Act (AUL.org/FOCA).

What will happen if and when FOCA is signed into law? Part B of Section 4, "Prohibition of Interference" clearly states, "A government may not —" deny or interfere with a woman's right to choose" to bear a child; to terminate a pregnancy prior to viability; or to

terminate a pregnancy after viability where termination is necessary to protect the life or health of the woman; or discriminate against the exercise of the rights set forth in paragraph (1) in the regulation or provision of benefits, facilities, services or information."

In essence, this statement challenges all state laws restricting abortion, the Hyde Amendment, the Mexico City Policy and the Supreme Court's Partial-Birth Abortion Ban. The result: Taxpayers will be required to pay for abortion on demand. Health-care providers will have to offer abortion benefits, and health-care workers will no longer be able to invoke the conscience clause. In addition, late-term restrictions on abortion will be revoked, and the Partial-Birth Abortion Ban will be nullified. Parental authority will be undermined as teens have access to abortion anywhere in the country without their parents' knowledge or consent.

This is a reversal of 35 years of laws, statutes and public and private efforts to decrease the number of abortions. According to the Guttmacher Institute, abortions have declined from a peak of 1.6 million in 1990 to 1.2 million in 2005, a 25% decrease

(Guttmacher.org/media/nr/2008/01/17/index.html) . Could this trend be attributable to abortion regulation as well as education and crisis-pregnancy assistance? Recent polls show that Americans are uncomfortable with abortion on demand and want some restrictions.

The final clause in Section 4 of FOCA is very telling about an additional intention of this legislation. It is titled "Civil Action" and states, "An individual aggrieved by a violation of this section may obtain appropriate relief (including relief against a government) in a civil action."

"Aggrieved" and "violation" are undefined and open to interpretation of what constitutes a grievance.

For example, if a sermon preached by a pastor or member of the clergy causes a woman who has had an abortion to feel discriminated against and consequently aggrieved, does this constitute a violation of FOCA? Can that church be sued or forfeit its tax-exempt status for such a violation?

What about people who pray or do sidewalk counseling outside of abortion clinics?

If a client is aggrieved by their presence, can the client sue on the basis of FOCA?

Could large-scale anti-abortion demonstrations, such as the March for Life, held annually on the anniversary of Roe v. Wade, become defendants of "Civil Action" or class-action law suits simply because they cause grievance on the basis of FOCA? Depending on its interpretation, this law could have tentacles that reach into the private lives and pro-life discourse of every American citizen.

Clearly this legislation means to silence dissent and, in turn, the entire pro-life movement.

Recall the phrase "fundamental right." What is actually at the heart of this legislation is the elevation of abortion to a "fundamental right" at all stages of development inside and outside of the womb.

Other fundamental rights are the right to vote and the right of free speech. By definition, a fundamental right is foundational. In the Declaration of Independence, life, liberty and the pursuit of happiness are enshrined as foundational principles.

One might infer that if FOCA is passed by Congress and signed into law by President Barack Obama, it will establish abortion as a fundamental right and also a foundational principle. We should think deeply and seriously before giving such lofty status to the practice of abortion.

# Joseph R. Meitz, KC Member for Past 35 Years, Recollects Overseeing Special Olympics for Six Years When Council 5300 Won Nationally Recognized Award

Joseph Roman Meitz, who joined the Knights of Columbus, Council 5300 on February 11, 1974, has many fond memories of many events that the Knights' sponsored, especially the Special Olympics begun by Grand Knight Max Keller during his 1977-78 leadership.

The native of Milwaukee, Wis., had the privilege of running the Olympics for six years with many Knights participating to assist the 300 to 400 Special Olympians involved in all the field events including wheelchair races.

Council 5300 was recognized nationally for hosting the Special Olympics and PGK Ralph Wengler went to the National Convention to receive the distinctive award. In 1984 Meitz, after his heart problems, relinquished the running of the Olympics to Dan Bunke.

Sponsored by Stanley Nowak, Meitz quickly became a 2nd Degree in March 1974 and a 3rd Degree in April. He held the position of Recorder and had hopes someday to becoming a Grand Knight but those plans were cut short when he had a serious heart operation with six bypasses in 1983. He retired from Delco Electronics nine months later as the Chief Draftsman.

"The best things about being a KC member," Meitz exclaimed, "are having many special friends and knowing much is being done for the Church and Community." Joe stated, "My main reason for joining the Knights was that I wanted to belong to an organization that was able to help those in need in the Parish as well as in the Community."

Joe and his wife Audrey and four of their eight children moved from Milwaukee in 1972 when he was transferred from AC Electronics (1949-72) to Delco Electronics in Santa Barbara as their Chief Draftsman. Meitz explained, "I was assigned by General Motors to a government committee developing Engineering Data Standards for government allowing duplicate manufacturing using like data when multiple procurement is required." There were 12 major firms involved including IBM, GE, and Lockheed.

Born on June 5, 1923 to Charles and Katherine Meitz, Joe's siblings included two sisters, Evelyn and Cecilia, and two brothers, Charles and Richard. Joe and Evelyn are the only survivors. He attended St. Agnes Grade School in Milwaukee, and Boys Technical High School. Joe reflected, "It was at a football game where I (age 17) met Audrey Ann Fleischmann (age 15) and never knew we lived only two blocks from each other." It must have been love at first sight as seven years later they were married on Oct. 26, 1946 at St. Leo's Catholic Church by Rev. Msgr. George Meyer.

Joe and Audrey were blessed with eight children: Robert, 61; Phillip, 60, James, 58; Mary Jo, 56; William, 52; Barbara, 50, Jeanne, 48 and David, 45. They also are proud of their 15 grandchildren and five great-grandchildren. They include: Heather 25, Paul 23, Adam 26, Lewis 12, Jerry 22, Michelle 21, Michael 18, Valarie 27, Jacob 25, Russell 16, Joel 33, Owen 16, Khloe 17, Jennifer 36, William 7 and great-grandchildren Bryce 6, Lexie 10, Alisa 14, Mathew 13 and Michael 4. Today the family is spread all over the country -- Montana, Nevada, Oregon, Milwaukee, New York and Ventura, CA.

After high school, still in the Great Depression of 1929, Joe signed a 5-year state indentured apprenticeship with Evinrude Motors in Product and Tool Design. He noted, "This was interrupted by World War II which I completed afterwards. It included working in all plant engineering associated departments and one year in manufacturing shop departments." He added, "It also required night schooling for five years in engineering courses at the Univ. of Wisconsin in Milwaukee."

Meitz served in the Air Force as a radioman/gunner on a B-17 (Flying Fortress) stationed in England at Kimbolton with the 379th Bomb Group, 527th Squadron. He pointed out, "I flew 32 missions, the last one July 18, 1944. All of our crew were awarded the Distinguished Flying Cross for completing our required number of missions." His last 10 months of service was in Laredo, Texas where he worked in an Air Force Engineering group before being discharged on October 11, 1945.

The keys to his success in his career were described as such: "1) Surround yourself with good competent people; 2). Treat all people the way you would like to be treated; 3). Keep abreast of the field you're in."

Joe and Audrey have been active in St. Raphael Parish since 1972. He was an Extraordinary Minister for 10 years and has been ushering at Mass for many years. Audrey, who celebrated her 83rd birthday on January 7, had been associated with the Women's Auxiliary and the Women's Bowling League. Joe has worked with Delco retirees for years with their Christmas Toys for Unity Shoppe. He has been an Elks Lodge member for 35 years and participated in the Elks Bowling League.

Hobbies include bowling for the past 40-years (high score 276), building grandfather clocks from kits and small wood working items. Travels since retirement have taken Joe and Audrey to Mexico, England, Wales, Scotland, Ireland,

Germany, Austria, Spain, Italy, Jamaica, Alaska, Hawaii, Canada and many U.S. states.

During their 36+ years at St. Raphael, they acknowledged that all the priests/pastors have been good and we liked them all.

Joe reminisced about his youth and a special priest in Milwaukee, Rev. Spieglehof, who was the CYO mentor at St. Leo's. Later Fr. Spieglehof went into the service in World War II and was featured on the cover of LIFE magazine celebrating Mass on the hood of a jeep. "I met up with Father again when he was a priest at a parish we belonged to - Mother of Perpetual Help," stated Joe. "I was sorry to hear that he died while still very young," reflected Meitz.

# 34 Widows among 263 Persons Receiving Monthly KC Council 5300's 'Knightline'

#### **Boy Scout Report**

Once a year I write this article to report to my Brother Knights about the work that they are doing to promote scouting here in the South Coast area. Goleta Valley Council is the proud sponsor of five Boy Scout units. Three of the units meet at St. Raphael's Church and two others meet in north Goleta at neighborhood schools.

It should be noted that the heads of each scout group: Cubmaster Mark Vampola, Scoutmaster Glenn Schiferl, and Crew Adviser Joe Bauer, are all Knights. This is not a coincidence, but recognition by the Knights to support the youth of our community.

#### Pack 105 – Cubmaster: Mark Vampola

Mark has a strong program involving many students from our parish school as well as a number of boys from local schools. This unit will achieve the Pope Paul VI Award from the Catholic Committee on Scouting. It was only two years ago that this unit was recognized as the best Catholic sponsored Cub Scout Pack in the western United States. Within the past year many of the boys earned either the Light of Christ or the Parvuli Dei Religious Emblems for Cub Scouts. Cubmaster Vampola was awarded the St. George Award by the Catholic Committee for his work

promoting religious emblems. In addition, Chaplain Wayne Rascati was presented the Msgr. James E. Dolan Award for long-term service to Catholic Scouting in the Archdiocese. The Pack assists the Parish by regular trash pick-up on parish grounds and assisting at the Parish Festival with children activities. The Council provides the wood block models for pinewood derby cars every December.

#### **Troop 105** – Scoutmaster: Glenn Schiferl.

As with Pack 105, Troop 105 will also earn the Pope Paul VI Award this year. This Award has also been given to the troop in successive years. The troop also had three boys achieve Eagle this year, with four others Eagle ceremonies to occur in early 2009. Achieving Eagle were Christopher Breton, Michael Schlesselmann, and Joseph Yonke. In addition, Chris Breton and Andrew Leicht earned the Pope Pius XII Religious Emblem last May; Tyler Casper (also of this Parish with Troop 37) was another recipient.

The Troop assisted the parish with the Parish Festival (by setting up and taking down all booths and served hotdogs and hamburgers during the event.) With the Cub Scout Pack, the Troop received much of its funding from the Christmas Tree Lot in the St. Raphael Parking Lot each December.

Troop 105 also attended Summer Camp at Camp Chawanakee (near Shaver Lake) and went on their annual week-long Sierra Hike. There were monthly outings which ranged from skiing to hiking. One highlight of the year was the regular contacts that they had with U.S. astronauts in space. Through modern technology the boys were able to hear from astronauts on board the Space Station and ask questions.

#### <u>Crew 105</u> – Adviser: Joseph Bauer.

This group of high school and college-age scouts meets informally throughout the year for social activities. Last year they went on a weekend outing to Lake Cachuma and sponsored a Parish Halloween festival.

#### Pack 36 – Cubmaster Bob Dutcher

This pack meets at Kellogg School and has a great program involving Pinewood Derby Racing and Rain Gutter Regatta. The Knights assist the Pack by sponsoring the Blue-Gold Dinner every March in our Parish Hall.

#### **Troop 36** – Scoutmaster Mike Errico

Troup 36 meets at Mountain View School. The Troop went to summer camp in Hawaii this past year and as a reserved space for hiking at Philmont Scout Ranch in 2009. This troop is self-sufficient from its Christmas Tree Lot in front of Long's Drug on Calle Real.

This year on February 8 we celebrate the start of the 99<sup>th</sup> year of Scouting in the United States. Scouts will assemble at St. Raphael's Church at the 7:30 Mass that day in recognition that A Scout is Reverent. 
