Verbal Engineering and the Swaying of Public Conscience

Over the years, a number of unjust laws have come to be replaced by more just ones. Laws overturning the practice of slavery, for example, were a significant step forward in promoting justice and basic human rights in society. Yet in very recent times, unjust and immoral laws have, with increasing frequency, come to replace sound and reasonable ones, particularly in the area of sexual morality, bioethics and the protection of human life. Whenever longstanding laws are reversed, and practices come to be sanctioned that were formerly forbidden, it behooves us to examine whether such momentous legal shifts are

morally coherent or not.

Concerns about moral coherence have always influenced the crafting of new laws, as they did in 1879 when the State of Connecticut enacted strong legislation outlawing contraception, specified as the use of "any drug, medicinal article or instrument for the purpose of preventing conception." This law, like the anti-contraception laws of various other states, was in effect for nearly 90 years before it was reversed in 1965. It codified the longstanding dictate of the public conscience that contraception was harmful to society because it promoted promiscuity, adultery and other evils. It relied on the nearly universal sensibility that children should be seen as a help and a blessing to society, and that, as Joseph Sobran puts it, "a healthy society, however tolerant at the margins, must be based on the perception that sex is essentially procreative, with its proper locus in a loving family."

Such a view had been remarkably deeply engrained in Western society for millennia, and interestingly, until as late as the 1930's, all Protestant denominations agreed with Catholic teaching condemning contraception. Not until the 1930 Lambeth Conference did the Anglican Church, swayed by growing societal pressure, announce that contraception would be allowed in some circumstances. Soon after, the Anglican Church yielded entirely, allowing contraception across the board. Since then, every major Protestant denomination has followed suit, even though their founders, including Luther, Calvin and Wesley, had all unhesitatingly condemned contraception, and insisted that it violated the right order of sexuality and marriage. Today, it is only the Catholic Church which teaches this traditional view.

How is it that modern times have seen such a striking reversal of this ancient view of the moral unacceptability of contraception? How is it that our age continues to witness a seemingly endless stream of legislative activity that promotes contraception through exorbitant government funding initiatives in nearly every major country

of the world, with American taxpayers providing, for example, more than \$260 million of Planned Parenthood's total income for 2004? Can something almost universally decried as an evil in the past suddenly become a good, or is such a legislative reversal not indicative of a significant misuse of law, and of a collective loss of conscience on an unprecedented scale?

Whenever widespread social engineering of this magnitude occurs, it is invariably preceded by skillful verbal engineering. The late Msgr. William Smith observed that the argument about contraception was basically over as soon as modern society accepted the deceptive phrase, "birth control" into its vocabulary. 'Imagine if we had called it, "life prevention",' he once remarked. The great Gilbert Keith Chesterton put it this way: "They insist on talking about Birth Control when they mean less birth and no control," and again: "Birth Control is a name given to a succession of different expedients by which it is possible to filch the pleasure belonging to a natural process while violently and unnaturally thwarting the process itself."

Fast on the heels of such seismic cultural shifts over contraception was even more radical legislation permitting abortion-on-demand. Since the early 1970's, such legislation has effectively enabled the surgical killing of 1 billion human beings worldwide who were living in the peaceful environment of a womb. Here too, sophisticated verbal engineering was necessary, since nobody could reasonably expect the abortion ethic to advance by saying, "Let's kill the kids." Many things simply cannot be achieved when it is clear to everyone what is going on; obfuscation is essential.

The growing child in the womb was thus recast as a "mass of tissue" or a "grouping of cells." The abortion procedure itself was re-described as "removing the product of conception" or "terminating a pregnancy" or simply, "the procedure." Those who were "pro-choice" obfuscated as to what the choice was really for. As one commentator put it, 'I think a more

realistic term would be "pro-baby killing".'

Euphemism, of course, has a serious reason for being. It conceals the things people fear. It is defensive in nature, offsetting the power of tabooed terms and otherwise eradicating from the language those matters that people prefer not to deal with directly. A healthy legislative process, however, will abstain from euphemism and obfuscation, zeroing in on truth and moral coherence. It will safeguard and promote an enlightened public conscience, particularly when crafting laws dealing with the most foundational human realities like sexual morality, bioethics and the protection of human life.

As I watched these youngsters battle with their

wits and skills, I was impressed with their dedication to a struggle with an alien subject (the law) that required countless hours of research and learning. After all, these are high school students, remember. The members of the judiciary and the bar who preside over or score these trials are always impressed with the results.

Every year, I ask the team members after the event if any of them plan on going into the law as a career. Out of the twenty members on each of the representative teams, four or five are thinking about a career in law. Nevertheless, the event is great training for those who participate. It also helps participants in getting admitted to top colleges in the country. It is not unusual for one of the seniors on a team in the finals to tell me that he or she has been accepted to Harvard, Yale or Stanford.

Why am I going on about this subject? First, I wanted to alert you to the competition so that you could attend one of these trials next year and see for yourself how great these youngsters are. The first rounds are usually held in the middle of February and the finals occur one week later. Secondly, I wanted to spend some time recognizing the effort being made by our local Catholic and independent private high school, Bishop Diego High School to get into this competition and become a regular player.

The problems are apparent; the local public schools have many more students from which they can select a team. Each school must field two teams, a prosecution team and a defense team and that requires a minimum of 9 for each team. Four years ago, Bishop could not collect enough applicants to get started. Bishop's student population is hovering somewhere under 300 at this time.

In spite of this, Tom Crawford, the football coach and teacher (and attorney) decided to have a team enter the competition last year. Bishop offered a class for Mock Trial and the students were interested. Tom talked local attorney parents into signing on as coaches and he convinced Pat

McCarthy and Henry Bongiovi to join his team. Each of the attorneys took charge of one of the teams and they began a process which still amazes them today.

Last year, their first year of competition, the Bishop team came in 7th out of 10 high schools after the first round. They bested schools which had been in the program for many years, and I heard a good number of compliments about their showing.

"Remember, Man is dust, and unto dust you shall return."

Ashes are a symbol of penance made sacramental by the blessing of the Church, and they help us develop a spirit of humility and sacrifice.

The distribution of ashes comes from a ceremony of ages past. Christians who had committed grave faults performed public penance. On Ash Wednesday, the Bishop blessed the hair shirts which they were to wear during the forty days of penance, and sprinkled over them ashes made from the palms from the previous year. Then, while the faithful recited the Seven Penitential Psalms, the penitents were turned out of the church because of their sins -- just as Adam, the first man, was turned out of Paradise because of his disobedience. The penitents did not enter the church again until Maundy Thursday after having won reconciliation by the toil of forty days' penance and sacramental absolution. Later, all Christians, whether public or secret penitents, came to receive ashes out of devotion. In earlier times, the distribution of ashes was followed by a penitential procession.

The Ashes

The ashes are made from the blessed palms used in the Palm Sunday celebration of the previous year. The ashes are christened with Holy Water

and are scented by exposure to incense. While the ashes symbolize penance and contrition, they are also a reminder that God is gracious and merciful to those who call on Him with repentant hearts. His Divine mercy is of utmost importance during the season of Lent, and the Church calls on us to seek that mercy during the entire Lenten season with reflection, prayer and penance.



Lent 2009: A time to 'make sacred' our many sacrifices

According to the calendar, Ash Wednesday occurs this week and we begin another Lent.

Except for this year.

Lent actually began in 2007 for many thousands of families all across the Archdiocese of Los Angeles, and we have been in a long and protracted season of Lent ever since. In what sense? The annual Lenten season calls us to reflect more deeply into our lives with God, to re-order our personal priorities according to the Gospel, and to live out increased personal sacrifice in our daily living.

With the economy continuing to spiral downwards day after day, with millions of jobs being eliminated, with people unable to make their house payments thus losing their homes, and with so many fearful of what tomorrow might bring --- we have truly been on a long Lenten

journey over these past two years. Incredible difficulties have burdened families: parents ever fearful that they cannot provide for their children, the unknown financial calamity that lurks just around the corner, the awful feeling of being one paycheck away from complete financial meltdown.

In prior years when life and our financial security were far more predictable, Lent meant that we could choose which special sacrifices we wanted to undertake --- but just for six weeks, until Easter Sunday. And then back to normal.

But now we have a new reality: we aren't choosing our sacrifices this year, they have chosen us. And they aren't just for six weeks; they have been our burden for over 75 weeks now with no sign of relief in sight.

This reality makes Lent 2009 unique and gives us the opportunity to enter this year's Lenten journey from a fresh and life-giving spirit. Most Catholics in our Archdiocese do not need to select a special form of sacrifice this Lent; they already have more than their share. So, how do we act differently this year?

Let me suggest that we recall the origin of the word "sacrifice." It comes from two Latin words: *sacrum* and *facere* --- meaning "to make sacred." A sacrifice, then, is accepting an ongoing or new reality --- usually burdensome --- and turning that into something sacred, a source of God's love and grace.

For me personally, this Lent means embracing the new wearisome burdens, difficulties and unexpected hardships that have confronted me on my journey of life and faith. I can't pretend that these difficult burdens aren't there, nor can I try to somehow sneak around them and move on - neither approach works. What I must do is recognize them, embrace them, realize I can't carry them alone, and "make sacred" all that surrounds me.

On Ash Wednesday as the minister places ashes on our forehead, these words are said: "Repent and believe in the Gospel."

It is *good* to mistrust ourselves, but how would that advantage us were we not to throw all our confidence on God, and to wait on His mercy?
