El Paso clergy, scientists at odds over stem-cell research

President Barack Obama on Monday lifted the ban on embryonic stem cell research. Religious leaders in El Paso called the practice immoral.

EL PASO -- Members of the scientific community in El Paso say they are "ecstatic" that President Barack Obama has made a move to fund embryonic stem cell research. Some religious leaders, however, call the use of embryonic instead of adult stem cells "immoral" and destroying one life to save another.

President Obama on Monday signed an executive order that opens the door to more extensive embryonic stem cell research. While calling it a difficult decision, Obama said he is supportive of broader research on embryonic stem cells because of the potential it holds for saving lives and helping those afflicted with diseases like

diabetes, Parkinson's and Alzheimer's.

The Rev. John Stowe, spokesman for the Catholic Diocese of El Paso, said the Catholic Church is opposed to embryonic stem cell research.

"An embryo is a human being. Recent research has indicated that the benefits from stem cell research can be obtained from adult stem cells. There is a concern on the part of the church that the increased use of embryonic stem cells for research will lead to the creation of human embryos for research purposes and then to be destroyed," he said.

Pastor Dennis McFarling of Scotsdale Baptist Church also said embryonic stem cell research is simply wrong.

"If it was a viable source of medical healing, there would be so many people investing private money, he wouldn't need to do this," McFarling said.

Like the El Paso diocese and the Catholic League for Religious and Civil Rights, McFarling stated that there are ethical alternatives, such as using adult cells.

In September 2008, Konrad Hochedlinger, a Harvard University stem cell researcher, said scientists were able to coax adult cells to regress into an embryonic state. The research was published by the journal Science.

Scientists, however, favor using embryonic stem cells because they are more flexible.

Renato Aguilera, director of a core facility at the Border Biomedical Research Center at the University of Texas at El Paso, said it would be hard to find any scientist "worth two pennies" who would be against embryonic stem cell research.

"It is incredibly important ... and the scientific community has been resentful that the government has interceded in the recent past. It held a lot of very good research back and I think Obama is righting a little bit of wrong," he said.

Aguilera said evidence points to a distinct possibility that embryonic stem cells could help very severe conditions including neurological diseases and spinal injuries.

"The only thing that scares people is the term 'embryonic,' but those are the most primitive cells possible. Without looking at what those cells can do -- perhaps regenerate the whole spine of a crippled individual -- if you stifle that kind of research, you'll never know what potential there will be," he said.

Charles Miller, an associate dean for research at Texas Tech University Health Sciences Center Paul L. Foster School of Medicine, called Obama's decision a "breakthrough."

"From a scientific point of view, it is a great opportunity to make significant strides in understanding the way particular neurological diseases like Parkinson's work and the treatments to fix those things."

Some religious leaders are supportive of embryonic stem cell research.

Pastor Juan Lawson of Holy Light Church of God in Christ, a former chairman of the department of physics at the University of Texas at El Paso, said he believes the question among the spiritual is when does life begin.

"Based on the Bible, God had already made a full-grown man from the dust of the Earth before breathing life into him. But I would probably take a chance and err on the side of trying to help those in the present who are living with spinal cord injuries. But I do believe we should be careful and ethical in terms of how we get those stem cells," he said.

Bob Reno, pastor of First Presbyterian Church, said in an e-mail that the Presbyterian Church

"affirms the use of fetal tissue and embryonic tissue for vital research. Our respect for life includes respect for the embryo and fetus, and we affirm that decisions about embryos and fetuses need to be made with responsibility."

Further the Presbyterian Church supports stem cell research with careful regulation and ongoing public dialogue on what the research finds.

Denise Watkins, director of the Alzheimer's Association, said she doesn't disapprove of more extensive embryonic stem cell research and believes there should be guidelines.

But she points out that no stem cell research has yet to have proved helpful in the treatment of Alzheimer's disease.

"I know that we have to do more research as the number of people who are at risk for Alzheimer's disease is increasingly greatly," she said. "But so far stem cell research has not shown to make a difference, but I'm hopeful."

His sponsor was Mike Fusano.

"Community service is the best thing about being a KC member," remarked Modugno who received his 4th degree on March 12, 1988.

Ralph's parents, Michael and Anna came from Bari, Italy (located on the "heal" of southern Italy) and were proud of their four children: Ralph, Angie, Frank and Sam. Ralph, the oldest, was born in San Fernando on January 23. He graduated from San Fernando Grammer School and High School. During World War II Ralph served in the U.S. Army Medical Corps and was stationed in Axminster, England from 1942-45.

After the service, Ralph met Helen Grace Barnett

while working together in a grocery store in Sun Valley. Helen, a native of Paris, Texas, had six brothers and sisters: Peter, Norma, Janis, Selma, Billy and Louis.

Ralph and Helen were married on October 3, 1952 at St. Ferdanand's Catholic Church in San Fernando by Rev. James Gordan. They are proud parents of David, Janet, Jerry, John, Suzie and Tom and nine grandchildren: Suchawadee Modugno (one year old), Nathan J. Logan, Emily Christine Logan, Kevin Dell, Alexa Dell, Heather Dell, Andrea Modugno, Tony Modugno and Danica Modugno.

The family moved to Goleta in 1963 and became members of St. Raphael Parish. Asked which pastor or priest was extra-special to them in these past 46-years, Ralph specified, "Msgr. Stephen Noel Downes because of his warmth and outgoing personality." Ralph's parish involvements included the Finance Committee, participating in the new Building Fundraising, picnics and Eucharistic Minister for several years. For years he has been most generous by donating food items to the Knights in their weekly Lenten Fish Fry dinners and monthly Pancake Breakfasts. Helen has served as President of the Women's Auxiliary on three different occasions. She taught CCD classes for five years and also was active in Women's Guilds. A few years ago she donated a beautiful yellow rose tree to St. Raphael and it remains in front of the Rectory. Some of the longtime parishioners call Helen, a native of Texas, the Yellow Rose of Texas. According to the couple the best thing about being parishioners at St. Raphael, "is it's a wonderful place to worship our God."

"The keys of my success in the grocery business," Ralph remarked, "were enjoying what you're doing and hard work." Since 1980 he has owned the two stores currently managed by sons John and Tom.



Following the Moral Compass

Recently, the Knights of Columbus commissioned a poll on public attitudes regarding the business ethics of corporate America. The poll, conducted by the Marist College Institute for Public Opinion, found that most Americans – and two-thirds of executives – give corporate America failing grades for honesty and ethics. They also rate the country's business leadership as poor during this time of economic crisis. Among the U.S. public, 76 percent believe that corporate America's moral compass is pointed in the wrong direction. Likewise, a majority of Americans, including two-thirds of executives, gave the financial and

investment industries a grade of "D" or "F" in ethical matters.

Asked what they believe to be the primary factors that drive the business decisions of executives, more than 90 percent of Americans – and executives themselves – said that personal career advancement and personal financial gain rank equally high with corporate advantage. Meanwhile, only 31 percent of Americans and 32 percent of executives believe that the "public good" is a strong factor in corporate decisions. When we released the poll results, I said that the present financial crisis was caused in no small part by greed. The public's confidence in our financial system, as well as in much of corporate America, will not be restored until executives and companies choose to be guided by a moral compass in their business decisions. I am convinced that only a strong commitment to ethical business practices on the part of executives and the companies they lead can restore this confidence.

Interestingly, three-fourths of Americans and more than nine in 10 executives think that a business can be both successful and ethical. Likewise, three-fourths of Americans and 86 percent of executives believe people should have the same ethical standards in business as in their personal lives. However, more than half of executives, and almost three-fourths of Americans, think that most people miss the mark.

To the news media, perhaps one of the survey's most surprising findings is a consensus that religion provides a good ethical standard for doing business. Nearly two-thirds of Americans believe that religious beliefs should significantly influence executives' business decisions, and executives are even more likely to agree.

These are all factors that may surprise some in the general public, but not the Knights of Columbus. As every brother Knight knows, the Order has an unwavering commitment to following a moral compass that always points in the same direction, "in season and out of season."

In his annual letter to Berkshire Hathaway investors, Warren Buffet recently described insurance as "a business of long-term promises, sometimes extending for fifty years or more. This past year has retaught clients a crucial principle: A promise is no better than the person or institution making it."

I could not agree more. We have kept our promise to the families of our brother Knights for 127 years. This is a tradition that every member of the Supreme Council is dedicated to preserving. Today, that promise continues to be backed not only by the financial strength of an AAA-rated corporation, but also by an unsurpassed commitment to our moral compass.

In Deus Caritas Est, Pope Benedict XVI wrote, "The Church is God's family in the world. In this family no one ought to go without the necessities of life" (25). The pope then analyzed this principle from the standpoint of both justice and charity.

We are proud that the Order's leadership is living out our commitment to charity – the first principle of the Knights.
