Insurance Agent's Report

Still have just group insurance?

As a Knights of Columbus field agent, I hear about group life insurance every week. If you have it, it's certainly not a bad thing, but it can be a misleading security blanket. Most times, the amount offered is far from what you need, and the only way to determine what you need is with a comprehensive needs analysis. Your group coverage is not based on any analysis. Instead, they apply a formula: you make X amount in salary and the group life is either a flat amount (\$15,000 seems popular) or a multiple of your salary (somewhere between 1.5 and 2.5 is common). Either way, it has nothing to do with the number of children you have, the mortgage balance you carry, or the amount of money your wife would need if you die. It's a completely random number.

It can also disappear at any time. All of us know people – friends, family members, neighbors – who have lost their jobs. When the job is lost, so is the group life insurance coverage. If the company experiences difficulty and budgets need to be cut, group life can be reduced or eliminated. And that decision could be made at the worst possible time for you.

Most group life insurance coverage reduces or disappears when you retire. Many times it can be converted, but at a very expensive premium (remember, you're no kid anymore when you retire, and premiums do rise as you get older). Just because you turn 65 doesn't mean you no longer need life insurance or need less coverage. Actually, the opposite is true.

Do you still own just group life insurance? It must be supplemented with a personally owned portfolio. I can tell you exactly how to blend your group benefit with your K of C life insurance so things can be in your control. Don't let the feeling of security that

group life provides distract you from the real issue: taking control of your family's financial future.

MODUGNO, Ralph Vito

January 30, 1923 - May 27, 2011

Ralph Vito Modugno passed away peacefully on Friday, May 27 in Santa Barbara. Born in San Fernando, California, the first son of Italian immigrants, Ralph went to work at an early age, helping his father pick grapes and olives in the fields of the San Fernando Valley. He learned to speak English in kindergarten and began working in a local grocery store as a teenager. He attended San Fernando High School where he played football and threw the shot put while continuing to work in the grocery business.

He served our country in World War II as a medical technician, spending three years in England. After the war, Ralph returned to San Fernando and the grocery store, moving quickly up the ranks to the position of manager. Perhaps unsurprisingly, he met his wife, Helen, in the same store, and they were married in 1948. Ralph eventually bought his own market and began raising a family in San Fernando. In 1963, the family relocated to Goleta. Ralph continued his career in the grocery business, managing or owning several markets in the Santa Barbara area. In 1979, he purchased the Goleta and Santa Barbara stores of the Santa Cruz Market chain, where he continued working until finally retiring in 2010 at the age of 87. All told, he worked more than 70-years in the grocery business, enjoying not only the work, but also the many friendships he made in the business and throughout the community. It truly was his passion.

When he was not working in his stores, he enjoyed working in the yard around his Goleta home. He was very active at St. Raphael Catholic Church and was a member of the Knights of Columbus for over 50-years.

A loving and playful father and grandfather, nothing

made him happier than spending time with his family. Visitors to his home often faced his persistent insistence that they stay for dinner. Ralph is survived by Helen, his wife of 62-years; his brother Sam; his sons, Jerry, David (Kathleen) Jon (Yao) and Tom (Kim); his daughters, Susie Logan (Jim) and Janet Dell (Jef) and 11 grandchildren. He was preceded in death by his parents, Michael and Anna; his brother Frank (Bonnie); and his sister, Angelina Scattaglia (Frank).

A Funeral Mass celebrated by Pastor Bruce Correio was held at St. Raphael Catholic Church on Friday, June 3, 2011 at 10 a.m. Granddaughter Alexa Dell gave a special tribute to Ralph by singing the "Ave Marie. A Vigil Service also was held there on Thursday, June 2, 2011 at 7 p.m. The family requests that, in lieu of flowers, donations be made to St. Raphael Catholic Church, 5444 Hollister Avenue, Santa Barbara, Ca. 93111-2308.

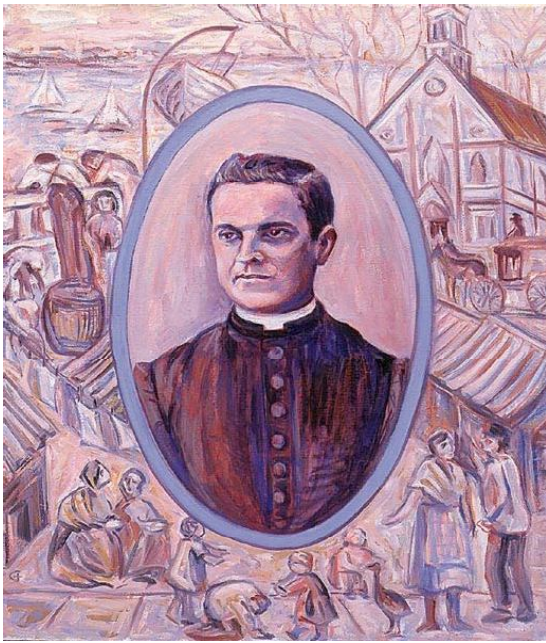
The history of the Knights of Columbus, Goleta Valley Council 5300, goes back to 1961 when Walter Daniel Merrigan, Jr., served two years as Grand Knight. Brother Merrigan became a Knight at age 18 in Las Vegas before moving to Santa Barbara and becoming the Grand Knight at age 32. Fifty Knights have served as Grand Knights since then with Edward Barrier the current installed leader for the 2011-12 Columbian year.

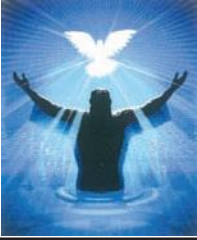

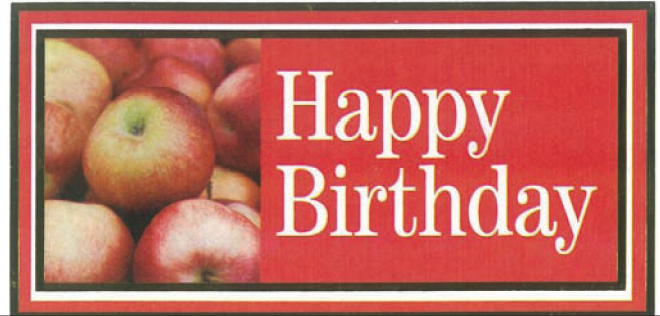

At this gathering Patrick presented his Scout history and project as three senior scout leaders from the South Coast District reviewed his scouting career and questioned him on the leadership he demonstrated in completing his project.

Scoutmaster Glenn Schiferl explained, "Patrick's project involved doing a lot of research, both on the Internet and using local sources. In creating this display for Rancho La Patera, Patrick had to understand the background and use of farm equipment, what might make it interesting to a wide variety of individuals and how to present that information in a durable manner."
