Joseph Alves Lima

Joseph Alves Lima, devoted to his family and friends, died after a brief illness on January 24, 2012. The son of John and Mary Lima of Newport, Rhode Island, he graduated from Rogers High School in 1944 and enlisted in the U.S. Army Air Corps. His service as a remote-control turret gunner on a Boeing B-29 took him to Mississippi, Nevada, Colorado and New Mexico. After the war, Joe attended the Milwaukee School of Engineering earning an Associate Electrical Technician degree.

In 1950, Joseph married Doris Mae Lango and began his career as a draftsman with the General Motors AC Sparkplug Division in Milwaukee. In 1972, he transferred to GM's Delco Electronics Division, moving with his wife and five of their six children to Goleta. He retired from Delco in 1987.

An active parishioner of St. Raphael Catholic Church in Goleta, Joe was a member of the Knights of Columbus 5300 for 36-years. He took particular satisfaction in his work with the KC's for the annual Special Olympics track and field events. An avid baseball player in high school and life-long Boston Red Sox fan, in later years, Joe enjoyed several activities including tennis, softball, bowling and square dancing. In retirement he traveled to Portugal, Hawaii, Alaska, Italy and Mexico and enjoyed socializing with family and friends. He will be remembered as someone who loved people and loved life.

Joseph was preceded in death by his wife, Doris M. Lima in 1993 and his son, John A. Lima in 2005. He is survived by his four sons and one daughter: Michael J. (Cindy) Lima of Franklin, Wisconsin, James T. Lima of Anchorage, Alaska, Robert T. (Kate) Lima of Goleta, CA., Andrew D. (Sonja) Lima of San Diego, CA., and JoAnn (Eric) VanCleave of Prescott Valley, Arizona; his brothers John Lima, Jr. of Newport, Rhode Island and Albert J. Lima of Bridgeport, Connecticut; as well as grandchildren: Luke, Zoe, Becky, Lilly, Trevor, Mike, JT, Katie and Meka and great-grandchildren Gabriel and Sam. He is also survived by his soul mate of 15-years, Eleanor J. Paulazzo of Goleta.

A rosary was offered for Joseph on Friday, January 27, 7 p.m. at St. Raphael's Church, 5444 Hollister Avenue in Goleta. A Funeral Mass was held at St. Raphael on Saturday, January 28 at 1 p.m. A reception followed immediately at Mulligan's. A private burial was held at a later date. **Pro-Life UPDATES:
Will Your Advance Directive Be Followed?

In the wake of the Terri Schiavo case, authorities have urged Americans to complete advance directives, like living wills, to state in which circumstances they would want medical treatment, food, and fluids if they become incapable of making these decisions. However, increasingly, health care providers who consider a patient's "quality of life" too low are defying these directives to deny treatment against patient and family wishes. The laws of all but ten states may allow doctors and hospitals to disregard advance directives when they call for treatment, food, or fluids, according to a report issued by the National Right to Life Committee Robert Powell Center for Medical Ethics April 15, 2005 (updated 2008).

A national Polling Company poll conducted April 8-11, 2005 (n 500; m/e 4.5%) shows 76 % of those told "A seriously ill patient has indicated they want food and fluids but the doctor thinks the patient's quality of life too low" say the patient should be able to receive food and fluids. Only 14% felt the doctor should be allowed to withhold them. Their position was similar concerning a patient who wants "life support" when the doctor says quality of life is too low: by 77% to 14%, the patient's view should prevail. These poll results, which are indicative of patient's thinking do line up with medical society guidelines.

For instance, The Society of Critical Care Medicine's Task Force on Ethics issued a "Consensus report on the ethics of foregoing life-sustaining treatments in the critically ill" which maintains that, "Both preservation of life and quality of life must be weighed when making decisions concerning withholding and withdrawing life-sustaining treatments." As one sympathetic medical commentator noted, under these guidelines, "Because treatment choices must be considered in relation to a patient's overall condition, a treatment offering a reasonable expectation of physiologic benefit may be withheld from terminally ill patients." Similarly, the American Thoracic Society issued an official

statement on "Withholding and Withdrawing Life-Sustaining Therapy" stating that life support "can be limited without the consent of the patient or surrogate when the intervention is judged to be futile." The paper defined "futile" as an intervention "that would be highly unlikely to result in a meaningful survival for the patient.... Survival in a state of permanent loss of consciousness...may be generally regarded as having no value for such a patient."

In light of this, it is not surprising that a study published in the Archives of Internal Medicine in 2004 analyzing compliance with advance directives through a survey consisting of hypothetical cases found that the treatment decisions physicians said they would make were inconsistent with the patients' advance directives in 65% of cases. Among the factors more likely to influence physicians' treatment decisions was the doctor's perception of the patient's "quality of life."

Dorothy Timbs, J.D., Legislative Counsel for the Powell Center for Medical Ethics, said, "We believe most Americans will be deeply disturbed that four-fifths of the states do not clearly protect their right to choose food, fluids, or life-preserving medical treatment. It is important to fill out an advance directive to make your wish not to be denied food or treatment clear. However, it is equally important to work for legal reform so that your choice for life will be honored."

Founded in 1968, the National Right to Life Committee (NRLC), the federation of 50 state right-to-life affiliates and more than 3,000 local chapters, is the nation's oldest and largest grassroots pro-life organization. Recognized as the flagship of the pro-life movement, NRLC works through legislation and education to protect innocent human life from abortion, infanticide, assisted suicide and euthanasia.

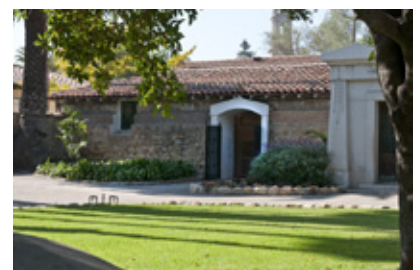
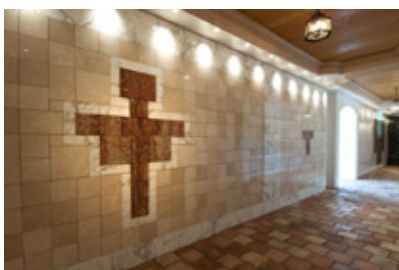

Dear Brothers,

Just wanted to thank you for your prayers and support during this difficult time in my life. I am living in an assistant living facility called Abundant Care located on Berkeley Road here in Goleta. I was living in my apartment until my eyesight began to fail in late Fall 2011. Also I fell down in my apartment and although not seriously injured it became apparent that independent living was no longer possible. So I moved here to Abundant Care in early December. Of course, it has been an adjustment for me, but it is much better than living alone with my disabilities.

In early February I did have a slight setback when I fell in my room here at Abundant Care and suffered several fractured bones. I am slowly healing and having physical therapy. The good part about being at Abundant Care is there are three meals a day that I don't have to prepare. Also I don't have to do the housekeeping and other daily tasks.

I try to stay busy listening to books on tape that I get from the Braille Institute and listen to TV. I was doing pool therapy a Vista del Monte and hopefully that will start again as soon as my strength returns. I was also doing some home exercises.

I enjoy hearing about the activities and events of Council 5300 and I miss not being able to read the monthly Knightline newsletter. Being blind is not as much fun as it should be.

I offer all my sufferings for the intentions of all of the Council members, their families and friends. I hope to be feeling better some time so I can come to Council activity or meeting and talk with everyone.

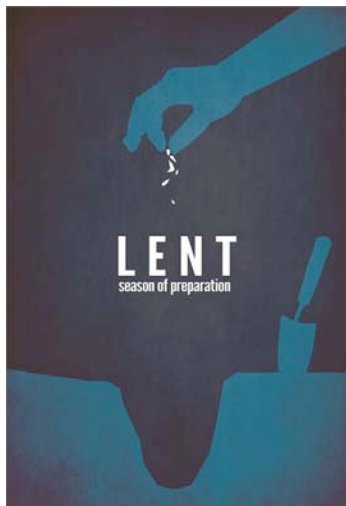
